You should use standard pricing from the FN Law Enforcement Distributor Agency price list for the quote. FN will charge \$45.00 per rifle for engraving and that should be listed as a separate line item on the Purchase Order. The minimum quantity for engraving is 50 units. Delivery for engraved rifles is 90-120 days ARO. Any agency wishing to have their rifles engraved will need to contact both FN, (Chris Dallas) and the distributor of record before issuing a PO. This is so a special SKU can be developed and the appropriate graphics can be secured and set up for the specific agency's rifle.
