Request for Proposal Title: Iowa Child Abuse Prevention Program Request for Grant Proposals

The Iowa Department of Human Services (Agency), Hoover State Office Building, Des Moines, Iowa, announces its intent to award to multiple apparent successful Bidders for the Iowa Child Abuse Prevention Program RFP (ACFS 19-003). A complete listing of all Bidders and the award amounts is enclosed, as well as a map of all Iowa counties, including all Projects received by the due date and evaluated (both funded and not funded).

Award amounts are based on the following funding methodology, with all amounts rounded to the nearest dollar:

Project Proposals for Parent Development, Home Visitation, Crisis Child Care, and Community Development

1. Proposals in the categories of Parent Development, Home Visitation, Crisis Child Care, and Community Development that earned an average of less than 50% of the total possible points are NOT funded.
2. Proposals that scored 50% or more of the total possible points were awarded a percentage of their total request based on the following scale:

% of Points	Funding Recommended
90 – 100%	80% of requested amount
80 – 89%	75% of requested amount
70 – 79%	70% of requested amount
60 – 69%	65% of requested amount
50 – 59%	60% of requested amount
Less than 50%	Not awarded

Project Proposals for Sexual Abuse Prevention

1. Proposals for Sexual Abuse Prevention Projects that earned less than 55% of the total possible points are NOT funded.
2. Funding for Projects scoring 55% or higher are awarded based on the following scale:

% of Points	Funding Recommended
95 – 100%	80% of requested amount
85 – 94%	75% of requested amount
75 – 84%	70% of requested amount
65 – 74%	65% of requested amount
55 – 64%	60% of requested amount
Less than 55%	Not awarded

As provided for in the RFP, this Notice of Intent to Award is subject to execution of a written contract. As a result, this Notice does NOT constitute the formation of a contract between the Agency and the apparent successful Bidder. The Bidder shall not acquire any legal or equitable rights relative to the contract services until a contract is executed. If the apparent successful Bidder fails to negotiate and execute a contract with the Agency, in its sole discretion, the Agency may revoke the Notice and enter into contract negotiations with another Bidder or withdraw the RFP. The Agency further reserves the right to cancel the Notice at any time prior to the execution of a written contract.

It is the Bidder's responsibility to assure timely delivery of the request for reconsideration. The request for reconsideration shall clearly and fully identify all issues being contested by reference to the page and section number of the RFP. If a Bidder submitted multiple Bid Proposals and requests that the Agency reconsider a decision for more than one Bid Proposal, a separate written request shall be submitted for each. At the Agency's discretion, requests for reconsideration from the same Bidder may be reviewed separately or combined into one response. The Division Administrator, Division of Adult, Children and Family Services, will expeditiously address the request for reconsideration and issue a decision. The Bidder may choose to file an appeal with the Agency within five days of the date of the decision on reconsideration in accordance with 441 IAC 7.41 et seq.


