The Department of Natural Resources (DNR) is seeking to purchase new Moulton irrigation parts and Rainbird 35A-TNT sprinkles or a State of Iowa approved equivalent. The Moulton and Rainbird parts are intended to illustrate the general characteristics of the irrigation parts and sprinklers needed and not meant to limit competition. All equivalents must provide detailed specifications with their quote.
