RFP Purpose.

The Iowa Department of Health and Human Services (referred to hereafter as "Agency") is seeking proposals from responsible Bidders that are experienced in working with Medicaid eligibility files, or the equivalent, and have the capability to provide implementation and operation services of an Asset Verification System (AVS). The AVS will identify assets held at various Financial Institutions (FIs) as well as real property assets held by Iowa Medicaid's Aged, Blind, and Disabled applicants and beneficiaries.

This RFP is being issued pursuant to both federal and state requirements. Section 1940 of the Social Security Act (42 U.S.C. §1396w) requires all states to implement an electronic asset verification program for verifying disclosed and undisclosed assets for purposes of determining and redetermining Medicaid eligibility of Aged (age 65 or over), Blind, or Disabled individuals. Section 1903 [42 U.S.C. 1396b] H(109)i and ii is also referenced as a funding source and oversight. Bidders shall propose a solution that uses Web-based techniques (Web-based user login, callable web-services to integrate with the Agency's systems, and system-to-system login with pass-through security) to identify assets that might not otherwise be discovered through the eligibility-determination process. Qualified Bidders are to present the State with a proposal that includes the following:

- 1. Establishment of a robust network of Financial Institutions (FIs)
- 2. Ability to identify real property assets
- 3. Implementation and operation of an electronic AVS
- 4. Tracking and reporting of verification activity

Duration of Contract.

The Agency anticipates executing a contract that will have an initial 5-year contract term with the ability to extend the contract for five (5) additional 1-year terms. The Agency will have the sole discretion to extend the contract.

Section 1 Background and Scope of Work

1.1 Background.

The Agency first procured an AVS in 2016 through a competitive procurement. At that time, the only requirement for an AVS was Title VII, Section 7001(d) of Public Law 110-252 (Supplemental Appropriations Act 2008) Section 1940 of the Social Security Act. States were required to implement an electronic mechanism for verifying the assets of Aged, Blind, or Disabled applicants and beneficiaries of Medicaid. The purpose of this requirement was to streamline Medicaid determinations.

There are approximately 115,000 individuals in Iowa currently receiving services with about 20,000 annual applicants who are considered Aged, Blind, or Disabled and are not receiving Social Security Supplemental Insurance. In 2023, there was an average of 10,150 AVS verification requests per month made through the Iowa AVS for Medicaid eligibility determinations.

This RFP is requesting offers from responsible Bidders to implement, maintain, and operate a Webbased AVS that interfaces to Agency systems. The Centers for Medicare and Medicaid Services (CMS), the USDA Food and Nutrition Service (FNS), and the Agency will provide oversight of the AVS.

Agency Mission and Vision

Iowa Medicaid's Mission:

lowa Medicaid is committed to ensuring that all members have equitable access to high quality services that promote dignity, barriers are removed to increase health engagement, and whole person health is improved across populations.

Iowa Medicaid's Vision:

lowa Medicaid works diligently to operate a fiscally responsible and sustainable program that improves the lives of its members through effective internal and external collaboration, innovative solutions to identified challenges, and data driven program improvement.

1.2 RFP Definitions.

General Definitions

When appearing as capitalized terms in this RFP, including attachments, the following quoted terms (and the plural thereof, when appropriate) have the meanings set forth in this section.

"Agency" means Iowa Health and Human Services (HHS).

"Bid Proposal" or "Proposal" means the Bidder's proposal submitted in response to the RFP.

"Bidder" means the entity that submits a Bid Proposal in response to this RFP.

"Contractor" means the Bidder who enters into a Contract as a result of this Solicitation.

"Deliverables" means all of the services, goods, products, work, work product, data (including data collected on behalf of the Agency), items, materials, and property to be created, developed, produced, delivered, performed, or provided by or on behalf of, or made available through, the Contractor (or any agent, contractor, or subcontractor of the Contractor) in connection with any contract resulting from this RFP.

"Invoice" means a Contractor's claim for payment. At the Agency's discretion, claims may be submitted on an original invoice from the Contractor or may be submitted on a claim form accepted by the Agency, such as a General Accounting Expenditure (GAX) form.

Definitions Specific to the RFP

"Aged, Blind, or Disabled" means an individual who is eligible for Medicaid due to being aged (age 65 or over), blind, or disabled and who is not an SSI recipient.

"Assets" means cash or other liquid resources or any real or personal property that is owned by an a person and is not legally restricted from using for support and maintenance, and that could be converted to cash to use for support and maintenance.

"Near Real-time" means a system response time of 0-2 minutes from the request sent by the Agency.

"Savings" means for the purpose of procurement, money saved due to the denial or closure of a Medicaid case solely due to the discovery of undisclosed assets that render the individual ineligible. The savings may only be calculated based on the period of time the undisclosed assets would render the individual ineligible.

"Secure Portal" means a Web-based application that meets the requirements outlined in 1.3.3 1.3.1.D.

"Web-based" means an external application that is accessed via a web browser over the internet. A Web-based application refers to any program that is accessed over a network connection using Secure Protocols (e.g., HTTPS, secure web Services, etc.) rather than existing within a device's memory. Web-based applications often run inside a web browser. Web-based applications also may be client-based, where a small part of the program is downloaded to a user's desktop, but processing is done over the internet on an external server.

"Security Incident" means is any event or situation involving the attempted or successful unauthorized access, use, disclosure, modification, destruction, or disruption of an electronic information asset, with the potential to compromise the confidentiality, availability, or integrity of lowa's resources including, but not limited to electronic data, applications, services, networks, mobile phones, computers, and devices. This includes incidents of lost or stolen physical data and assets, and incidents of information spillage which occurs when classified data is spilled either onto an unclassified information system or to an information system with a lower level of classification or different security category. An information system incident is a significant information system disruption which currently or may in the future result in a mission critical business impact.

1.3 Scope of Work.

1.3.1 Deliverables

The Bidder shall provide the following:

1.3.1.1 General Obligations

- A. Required Technical Obligations
 - 1. The Bidder shall deliver an AVS that meets all of the federal and State requirements including, but not limited to:
 - a) All requirements of the Centers for Medicare/Medicaid Services
 - b) Title VII, Section 7001(d) of P.L.110 252 (supplemental Appropriations Act 2008) Section 1940 of the Social Security Act
 - 1. The AVS shall send and receive inquiries and verifications electronically with the FIs and the Agency.
 - 2. The AVS shall not be based on mailing or faxing paper-based requests.
 - 3. The AVS shall provide for both electronic submission of requests to FIs and the electronic receipt of responses from FIs.
 - 2. Financial Accounts.

The Bidder shall deliver an AVS that has access to FIs. The list of FIs may include, but is not limited to, the following:

- a) Checking account
- b) Savings account
- c) Investment accounts
- d) Individual Retirement Accounts (IRAs)
- e) Treasury notes
- f) Annuities
- g) Certificate of deposits (CDs).
- h) Custodial accounts
- i) Burial or funeral accounts
- j) Money market accounts
- k) Retirement plans
- Rent securities

- m) Trusts
- n) Life insurance cash values
- o) Christmas club accounts
- p) Direct Express accounts
- q) Any other assets that may be held or managed by a FI
- 3. Look Back Review.

The Bidder shall deliver an AVS that:

- a) Looks at accounts going back for a period of sixty (60) months prior to the month of application.
- b) Requests information concerning both open and closed accounts.
- c) Determines if the client's name appeared on any account as a single or joint owner during the look-back period.
- 4. Verification Requests.

The Bidder shall deliver an AVS that:

- a) Allows for verification requests to be sent to FIs based on the applicant's declaration or the Agency's selection of possible banking activity.
- b) Allows for verification requests to be sent to FI's other than those identified by the applicants and recipients based on, but not limited to the geographic proximity to the applicant's home address or residential history when it is determined by the Agency that the verification requests are needed to determine and re-determine the individual's eligibility.
- c) Provides an option for the Agency staff to specify an FI.
- 5. Cross State Responses.

The Bidder shall deliver an AVS that provides for cross state responses to queries regarding assets to include FIs located outside of lowa.

- 6. Reporting.
 - a) The winning Bidder shall provide FI monthly documentary reports that include, at a minimum, the following information:
 - i. Transaction record
 - ii. AVS performance report
 - iii. AVS availability report
 - iv. FI network report
 - v. AVS customer service metrics
 - vi. High balance report
 - vii. Iowa inquiry list
 - b) The reports must contain information on all searches, even if no assets are found.
 - c) The Contractor shall collaborate with the Agency's contract manager or delegated Agency staff to correct any discrepancies between any of the Contractor's provided reports and the Agency's internal records prior to payment being issued.
 - d) Ad hoc reporting, upon Agency request.
- 7. Training and Support.
 - a) The Contractor shall provide Agency approved training to both the Agency and FI staff.
 - b) The Contractor shall provide Agency approved customer support to both the Agency and FI staff
 - c) The Contractor shall develop, implement, and adhere to an Agency approved training plan.

B. Network of Financial Institutions

- 1. FI Network
 - a) The Bidder shall have an established network of geographically diverse FIs in Iowa that will participate in the AVS.

- b) The Bidder shall have an established network of geographically diverse FIs out-ofstate that will participate in the AVS.
- c) The Bidder shall maintain a letter of commitment from each FI that indicates the level of access and communication agreed to by the FI.

2. FI Recruiting

- a) The Bidder shall have an established system for recruiting Fls.
- b) The Bidder shall establish and maintain a good working relationship with FI's and professional associations.
- c) The bidder shall have innovative and creative strategies to recruit FI.

C. Optional Technical Obligations

1. Real Property Assets.

If available. the Bidder may deliver real property information through an AVS that has access to real property assets. The list of real property assets may include, but is not limited to, the following:

- a) Real-estate property
- b) Motor Vehicle registration
- c) Off-highway recreational vehicle registration including, but not limited to, motorcycles, snowmobiles, and all-terrain vehicles
- d) Recreational vehicle registrations including, but not limited to, campers, motorhomes, campervans, and travel trailers
- e) Watercraft information
- f) Aircraft registration
- 2. Look Back Review.

If available, the Bidder may deliver real property information through an AVS that:

- a) Looks at real property information that may go back for a period of at least sixty (60) months prior to the month of application.
- b) Determines if the client's name appeared on any real property as a single or joint owner during the look-back period.
- 3. Cross State Responses.

If available, the Bidder may deliver real property information through the AVS that provides for cross state responses to queries regarding assets to include real property assets located outside of lowa.

- 4. Reporting.
 - a) If real property information is available, the winning Bidder may provide real property monthly documentary reports that include, at a minimum, the following information:
 - 1. Information to identify the property including, but not limited to:
 - a. Address location
 - b. Plat or tax identification number assigned to the property
 - c. Governing jurisdiction where the title is held
 - 2. Assessed value of the property by the relevant taxing authority
 - 3. Name of the taxing authority
 - 4. Names of co-owners of the property
 - 5. Transaction history of the property that includes, but is not limited to:
 - a. Date of transaction
 - b. Price of transaction
 - c. Parties involved in transaction
 - d. Type of transaction
 - 6. Motor vehicle registration information
 - 7. Off highway recreational vehicle registration information

- 8. Recreational vehicle registration information
- 9. Watercraft registration information
- 10. Aircraft registration information
- 11. Requestor's username and ID
- 12. Requestor's supervisor name
- 13. Requestor's district office number
- b) If real property information is available, the reports must contain information on all searches, even if no assets are found.
- c) If real property information is available, the winning Bidder may collaborate with the Agency's contract manager or delegated Agency staff to correct any discrepancies between any of the Contractor's provided reports and the Agency's internal records prior to payment being issued.
- d) Ad hoc reporting, upon Agency request.
- 5. Training and Support.
 - a) If real property information is available, the winning Bidder may provide Agency approved training to both the Agency and Providers of real property staff.
 - b) If real property information is available, the winning Bidder may provide Agency approved customer support to both the Agency and Providers of real property staff.
 - c) If real property information is available, the winning Bidder may develop, implement, and adhere to an Agency approved training plan.

D. Security and System Requirements.

- 1. Security Requirements
 - a) The Bidder shall ensure the highest level of security as set forth by NIST 800-53 Rev 5
 - b) The Bidder shall comply with all state and Agency privacy and security requirements notified to the Bidder in advance.
 - c) The Bidder shall comply with the Health Insurance Portability and Accountability Act (HIPAA) found at: https://hhs.iowa.gov/hipaa or such other terms and conditions as the parties may agree in writing if the Bidder is a Business Associate as defined by HIPAA.
 - d) The Bidder shall ensure that the system and Confidential Information is not accessed from outside the continental United States.
- 2. System Requirements.
 - a) The AVS shall meet at a minimum the following standards:
 - i SAS 70
 - b) National Institute of Standards and Technology (NIST) 800-53 Rev 5 The Bidder shall assure seamless coordination between the Agency, the FIs, and other systems as necessary.
 - c) The Bidder shall establish and maintain back-up and recovery procedures to meet NIST standards.
 - d) The Bidder shall submit data file formats and data fields that will interface with Agency systems.
 - e) The Bidder shall encrypt data in transit and at rest. Encryption settings shall be set for the strongest encryption available.
 - f) The Bidder shall ensure access levels are set at least privilege.
 - g) The Bidder shall incorporate MFA and SSO at the state's direction.
 - h) The Bidder shall classify and label all data according to the agency's data classification and labeling policies.
 - i) The bidder shall ensure penetration testing and vulnerability testing is conducted prior to implementation and at a frequency as determined by the agency thereafter.

j) The bidder shall ensure a process to report security incidents to the Agency within 72 hours.

E. Financial Statements.

The Contractor shall submit annually an electronic copy of the Contractor's current fiscal year audited financial statement from independent auditors. If the Contractor is not required to have audited financial statements, the Contractor shall submit CPA-prepared unaudited financial statements. The financial statement shall be submitted to the Agency contract manager no more than nine (9) months past the close of the Contractor's fiscal year.

1.3.1.2 Transition Phase

A. Planning

The Contractor shall develop and comply with project work plans, subject to Agency approval that include the following:

- 1. A transition plan detailing the Contractor's strategy to implement the staff, systems, and services contemplated by this contract.
- 2. A systems implementation plan detailing implementation, quality assurance, and testing activities related to the Contractor's system solutions.
- 3. An operations plan detailing the daily performance of all required activities by the Bidder, including required coordination and safeguards.
- 4. A reporting plan detailing requirements for submitting reports to the Agency. This plan shall be developed in consultation with the Agency. Reporting plan requirements include but are not limited to:
 - a. Use of standard naming conventions,
 - b. Templates for standardized reports that may be necessary to implement the project. The Contractor shall revise the report content as needed upon Agency request.
 - c. Detail of whom the reports should be delivered to for review and approval, as necessary, and
 - d. Frequency and due dates for reports.
- 5. A training plan detailing, at a minimum:
 - a. Training of FIs in system and operational procedures required to perform the Contractor's functions under the Contract,
 - b. Training of real property providers in system and operational procedures required to perform the Contractor's functions under the Contract,
 - c. Continuous standard operating procedures training process for Contractor staff. At a minimum, the winning Bidder shall train Contractor staff when:
 - d. New Contractor staff or replacement staff are hired,
 - e. New policies or procedures are implemented, and
 - f. Changes are made to any existing policies or procedures prior to the change's implementation if possible, and if not, concurrent with the change's implementation.
 - g. Training of Agency employees, as requested. Such training shall be at no additional cost to the Agency.

B. Operational Readiness

- 1. The Contractor shall prepare for the onset of operations in the existing Agency environment. This includes but is not limited to the following:
 - a. Review the turnover plan from the outgoing contractor.
 - b. Utilize the Agency's comprehensive operational readiness checklist of its start-up activities.
 - c. Develop and implement a corrective action plan for all outstanding activities for review and approval by the Agency.

- d. Conduct training for its staff.
- e. Gather and document all Agency technical and operational requirements pertaining to work performed under this procurement.
- f. Produce and update all operations documentation, to include SOPs, and obtain Agency approval of each iteration.
- g. Establish Agency-approved interfaces, as necessary.
- h. Provide the Agency assurance that all checklist activities have been satisfactorily completed and signed-off by the Agency.
- i. Obtain written approval from the Agency to start operations.
- j. Provide all documentation as required for approval o the Department of Management, Division of IT for the Assessment, Authorization and Monitoring Process. This includes a privacy impact analysis, system security plan, data flow diagrams, network diagrams, vendor assessment forms, PPSM and hardware/software/cloud list.
- k. Provide a SOC 2 report to the Department of Management, DoIT, for review prior to implementation and annually thereafter.
- 2. The Contractor shall work proactively with the Agency and the outgoing Contractor to take over the management of any work that remains open when the outgoing contract ends on June 30, 2025.

1.3.1.3 Turnover Phase

Within this final phase of the Contract, the Contractor turns over operations to a new contractor near the end of the Contract term. This phase is activated when the Agency enters into a contract with a new entity (such as a newly awarded contractor) and begins the process of transferring responsibility for operations to that entity.

Once the turnover phase begins, the Contractor shall:

- A. Fully cooperate with the Agency and new entity.
- B. Develop and comply with a turnover plan detailing the activities necessary to transfer responsibility for operations to the new entity.

1.3.2 Performance Measures.

1.3.2.1 General Requirements

- A. The AVS shall provide an Agency approved response of the finding or non-finding of a match for one hundred percent (100%) of all requests.
- B. When a match is found with one or more FI, results shall be provided in an Agency approved format within ten (10) calendar days for ninety-eight percent (98%) of the requests.
- C. Contractor shall ensure that its Web-based verification system is accessible to the Agency twenty-four (24) hours per day, seven (7) calendar days per week and has an uptime of no less than ninety-eight percent (98%) as measured on a monthly basis.
- D. Contractor shall provide a minimum of forty-eight (48) hours written notice in advance of a planned outage where the system will be unavailable.
- E. Contractor shall provide a confirmation of any unplanned outage within one (1) hour of the system being unavailable.
- F. Contractor shall provide dates that assets were made available to applicants or members as of the first day of each month, before any other transaction.
- G. Reporting
 - 1. Contractor shall deliver accurate and timely reports to the Agency. All submitted reports shall be clear, concise, and objective, free from typographical errors, and come to logical conclusions.

- 2. Unless otherwise specified, the Contractor shall provide all identified reports in an Agency-approved format and in accordance with timeframes established in the Agency-approved reporting plan.
- 3. Contractor shall submit reports within the timeframes established in the Agency-approved reporting plan and according to the following schedule, unless otherwise specified within the Agency-approved reporting plan:
 - a. Weekly reports: within two business days of end of reporting period.
 - b. Monthly reports: within ten business days of end of reporting period.
 - c. Quarterly reports: within fifteen business days of end of reporting period.
 - d. Annual reports: within twenty business days of end of reporting period.
 - e. Ad hoc reports: within two business days of request, unless otherwise specified. The Contractor will track ad hoc requests with due date and delivery date, reporting with monthly reporting.
 - f. Reporting log: The Contractor will include the monthly report a list of regularly occurring and ad hoc reports including data on reports requested, reports completed, reports submitted, who reports were submitted to, and relevant dates.
 - g. Revised reports shall be submitted within five business days of request unless otherwise indicated by the Agency.

1.3.2.2 Transition

- A. The Contractor shall submit transition and operations plans to the Agency for approval within 15 business days of the execution of this procurement's contract, unless otherwise specified.
- B. The Contractor shall submit the reporting and training plans to the Agency for approval within 20 business days after the execution of this procurement's contract.

1.3.3 Contract Payment Methodology.

The Agency will pay Contractor on an agreed upon time frame for services provided pursuant to this Contract. The total cost of services, whether they are billed on a yearly flat-fee basis or a per-lookup basis, or another proposed methodology may not exceed a maximum allowable Contract value determined by State appropriation. in accordance with the pricing set forth in Attachment F (i.e., the Cost Proposal).

Section 2 Basic Information About the RFP Process

2.1 Issuing Officer.

2.2 Restriction on Bidder Communication.

From the issue date of this RFP until announcement of the successful Bidder, the Issuing Officer is the point of contact regarding the RFP. There may be no communication regarding this RFP with any State employee other than the Issuing Officer, except at the direction of the Issuing Officer or as otherwise noted in the RFP. This section shall not be construed as restricting communications related to the administration of any contract currently in effect between a Contractor and the Agency.

The Issuing Officer will respond only to questions regarding the procurement process. Questions pertaining to the interpretation of this RFP may be submitted in accordance with the Questions, Requests for Clarification, and Suggested Changes section of this RFP.

2.3 Downloading the RFP from the Internet.

The RFP and any related documents such as amendments or attachments (collectively the "RFP"), and responses to questions will be posted at the State of Iowa's website for bid opportunities: http://bidopportunities.iowa.gov/. Check this website periodically for any amendments to this RFP. The posted version of the RFP is the official version. The Agency will only be bound by the official version of the RFP document(s). Bidders should ensure that any downloaded documents are in fact the most up to date and are unchanged from the official version.

2.4 Reserved. (Online Resources)

2.5 Intent to Bid.

The Agency requests that Bidders provide their intent to bid by email to the Issuing Officer by the date and time in the Procurement Timetable. The Bidder may wish to request confirmation of receipt of the email from the Issuing Officer to ensure delivery. Do not submit letters of intent by mail, shipping service, or hand delivery. The intent to bid should include the Bidder's name, contact person, mailing address, email address, telephone number, and a statement of intent to submit a bid in response to this RFP. Though it is not mandatory that the Agency receive an intent to bid, the Agency will only respond to questions about the RFP that have been submitted by Bidders who have expressed their intent to bid. The Agency may cancel an RFP for lack of interest based on the number of letters of intent to bid received.

2.6 Reserved. (Bidders' Conference)

2.7 Questions, Requests for Clarification, and Suggested Changes.

Bidders who have provided their intent to bid on the RFP are invited to submit written questions, requests for clarifications, and/or suggestions for changes to the specifications of this RFP (hereafter "Questions") by the due date and time provided in the Procurement Timetable. Bidders are not permitted to include assumptions in their Bid Proposals. Instead, Bidders shall address any perceived ambiguity regarding this RFP through the question-and-answer process. If the Questions $Page \mid 13$

pertain to a specific section of the RFP, the page and section number(s) must be referenced. Bidders shall submit questions to the Issuing Officer by email. The Bidder may wish to request confirmation of receipt from the Issuing Officer to ensure delivery. Do not submit questions by mail, shipping service, or hand delivery.

The Agency will post responses to questions received on the State's website at: http://bidopportunities.iowa.gov/ by the dates provided in the Procurement Timetable. Follow-up questions to initial responses are permissible as long as all questions are received by the final due date and time for Bidder Questions as provided in the Procurement Timetable.

The Agency assumes no responsibility for verbal representations made by its officers or employees unless such representations are confirmed in writing and incorporated into the RFP. In addition, the Agency's written responses to Questions will not be considered part of the RFP. If the Agency decides to change the RFP, the Agency will issue an amendment.

2.8 Submission of Bid Proposal.

Each Bidder is responsible for ensuring that the Issuing Officer receives the Bid Proposal by the time and date specified in the Procurement Timetable at the address provided in the RFP for the Issuing Officer. The Agency will not waive this mandatory requirement. Any Bid Proposal received after this deadline will be rejected and will not be evaluated.

Bid Proposals are to be submitted in accordance with the Bid Proposal Formatting section of this RFP. Bid Proposals may not be hand-delivered to the Issuing Officer. Rather, Bid Proposals are to be mailed through the postal service or shipping service.

2.9 Amendment to the RFP and Bid Proposal.

Each Bidder is responsible for ensuring that the Issuing Officer receives the Bid Proposal and any permitted amendments by the established deadlines at the address provided in the RFP for the Issuing Officer. Amendments must be received utilizing the same delivery method as set forth in the RFP for the submission of the original Bid Proposal.

Bidders may amend a previously submitted Bid Proposal at any time before the bid submission date and time. Any such amendment must be in writing and signed by the Bidder. The Bidder shall provide the same number of copies of the amended Bid Proposal as is required for the original Bid Proposal, for both hardcopy and electronic copies, in accordance with the Bid Proposal Formatting Section.

The Agency reserves the right to amend or provide clarifications to the RFP at any time. RFP amendments will be posted to the State's website at http://bidopportunities.iowa.gov/. If an RFP amendment occurs after the closing date for receipt of Bid Proposals, the Agency may, in its sole discretion, allow Bidders to amend their Bid Proposals.

2.10 Withdrawal of Bid Proposal.

The Bidder may withdraw its Bid Proposal prior to the closing date for receipt of Bid Proposals by submitting a written request to withdraw signed by the Bidder, scanned, then emailed to the Issuing Officer. The Bidder should request confirmation of receipt of the email from the Issuing Officer to ensure delivery.

2.11 Costs of Preparing the Bid Proposal.

The costs of preparation and delivery of the Bid Proposal are solely the responsibility of the Bidder.

2.12 Rejection of Bid Proposals.

The Agency reserves the right to reject any or all Bid Proposals, in whole and in part, and to cancel this RFP at any time prior to the execution of a written contract. Issuance of this RFP in no way constitutes a commitment by the Agency to award or enter into a contract.

2.13 Review of Bid Proposals.

Only Bidders that meet the mandatory requirements and are not subject to disqualification will be considered for award of a contract.

2.13.1 Mandatory Requirements.

Bidders must meet these mandatory requirements or will be disqualified and not considered for award of a contract:

- The Issuing Officer must receive the Bid Proposal, and any amendments thereof, prior to or on the due date and time (See RFP Sections 2.8 and 2.9).
- The Bidder is not presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from receiving federal funding by any federal department or agency (See RFP Additional Certifications Attachment).

2.13.2 Reasons Proposals May be Disqualified.

Bidders are expected to follow the specifications set forth in this RFP. However, it is not the Agency's intent to disqualify Bid Proposals that suffer from correctible flaws. At the same time, it is important to maintain fairness to all Bidders in the procurement process. Therefore, the Agency reserves the discretion to permit cure of variances, waive variances, or disqualify Bid Proposals for reasons that include, but may not be limited to, the following:

- Bidder initiates unauthorized contact regarding this RFP with employees other than the Issuing Officer (See RFP Section 2.2).
- Bidder fails to comply with the RFP's formatting specifications so that the Bid Proposal cannot be fairly compared to other bids (See RFP Section 3.1).
- Bidder fails, in the Agency's opinion, to include the content required for the RFP.
- Bidder fails to be fully responsive in the Bidder's Approach to Meeting Deliverables Section, states an element of the Scope of Work cannot or will not be met, or does not include information necessary to substantiate that it will be able to meet the Scope of Work specifications (See RFP Section 3.2.3).
- Bidder's response materially changes Scope of Work specifications.
- Bidder fails to submit the RFP attachments containing all signatures (See RFP Section 3.2.6).
- Bidder marks entire Bid Proposal confidential, makes excessive claims for confidential treatment, or identifies pricing information in the Cost Proposal as confidential (See RFP Section 3.1).
- Bidder includes assumptions in its Bid Proposal (See RFP Section 2.7); or
- Bidder fails to respond to the Agency's request for clarifications, information, documents, or references that the Agency may make at any point in the RFP process.
- Bidder is a "scrutinized company" included on a "scrutinized company list" created by a public fund pursuant to Iowa Code §12J. This list is maintained by the Iowa Public Employees' Retirement System. The list is currently found here: https://ipers.org/investments/restrictions.

The determination of whether or not to disqualify a proposal and not consider it for award of a contract for any of these reasons, or to waive or permit cure of variances in Bid Proposals, is at the sole discretion of the Agency. No Bidder shall obtain any right by virtue of the Agency's election to not exercise that discretion. In the event the Agency waives or permits cure of variances, such

waiver or cure will not modify the RFP specifications or excuse the Bidder from full compliance with RFP specifications or other contract requirements if the Bidder enters into a contract.

2.14 Bid Proposal Clarification Process.

The Agency may request clarifications from Bidders for the purpose of resolving ambiguities or questioning information presented in the Bid Proposals. Clarifications may occur throughout the Bid Proposal evaluation process. Clarification responses shall be in writing and shall address only the information requested. Responses shall be submitted to the Agency within the time stipulated at the occasion of the request.

2.15 Verification of Bid Proposal Contents.

The contents of a Bid Proposal submitted by a Bidder are subject to verification.

2.16 Reference Checks.

The Agency reserves the right to contact any reference to assist in the evaluation of the Bid Proposal, to verify information contained in the Bid Proposal, to discuss the Bidder's qualifications, and/or to discuss the qualifications of any subcontractor identified in the Bid Proposal.

2.17 Information from Other Sources.

The Agency reserves the right to obtain and consider information from other sources concerning a Bidder, such as the Bidder's capability and performance under other contracts, and the Bidder's authority and ability to conduct business in the State of Iowa. Such other sources may include subject matter experts.

2.18 Criminal History and Background Investigation.

The Agency reserves the right to conduct criminal history and other background investigations of the Bidder, its officers, directors, shareholders, or partners and managerial and supervisory personnel retained by the Bidder for the performance of the resulting contract. The Agency reserves the right to conduct criminal history and other background investigations of the Bidder's staff and subcontractors providing services under the resulting contract.

2.19 Disposition of Bid Proposals.

Opened Bid Proposals become the property of the Agency and will not be returned to the Bidder. Upon issuance of the Notice of Intent to Award, the contents of all Bid Proposals will be in the public domain and be open to inspection by interested parties subject to exceptions provided in Iowa Code chapter 22 or other applicable law.

2.20 Public Records and Request for Confidential Treatment.

Original information submitted by a Bidder may be treated as public information by the Agency following the conclusion of the selection process unless the Bidder properly requests that information be treated as confidential at the time of submitting the Bid Proposal. See the Bid Proposal Formatting Section for the proper method for making such requests. The Agency's release of information is governed by Iowa Code chapter 22. Bidders are encouraged to familiarize themselves with Chapter 22 before submitting a Bid Proposal. The Agency will copy public records as required to comply with public records laws.

The Agency will treat the information marked confidential as confidential information to the extent such information is determined confidential under lowa Code chapter 22 or other applicable law by a court of competent jurisdiction. However, the Bidder shall certify by signing and returning RFP Attachment B its understanding that any Agency references to Bid Proposal information marked confidential made during the evaluation process may become part of the public domain.

In the event the Agency receives a request for information marked confidential, written notice shall be given to the Bidder seventy-two (72) hours prior to the release of the information to allow the Bidder to seek injunctive relief pursuant to lowa Code § 22.5 or 22.8.

The Bidder's failure to request confidential treatment of material pursuant to this section and the relevant law will be deemed, by the Agency and State personnel, as a waiver of any right to confidentiality that the Bidder may have had.

2.21 Copyrights.

By submitting a Bid Proposal, the Bidder agrees that the Agency may copy the Bid Proposal for purposes of facilitating the evaluation of the Bid Proposal or to respond to requests for public records. By submitting a Bid Proposal, the Bidder acknowledges that additional copies may be produced and distributed and represents and warrants that such copying does not violate the rights of any third party. The Agency shall have the right to use ideas or adaptations of ideas that are presented in the Bid Proposals.

2.22 Release of Claims.

By submitting a Bid Proposal, the Bidder agrees that it shall not bring any claim or cause of action against the Agency based on any misunderstanding concerning the information provided herein or concerning the Agency's failure, negligent or otherwise, to provide the Bidder with pertinent information as intended by this RFP.

2.23 Reserved. (Presentations)

2.24 Notice of Intent to Award.

Notice of Intent to Award will be sent to all Bidders that submitted a Bid Proposal by the due date and time. The Notice of Intent to Award does not constitute the formation of a contract between the Agency and the apparent successful Bidder.

2.25 Acceptance Period.

The Agency shall make a good faith effort to negotiate and execute the contract. If the apparent successful Bidder fails to negotiate and execute a contract, the Agency may, in its sole discretion, revoke the Notice of Intent to Award and negotiate a contract with another Bidder or withdraw the RFP. The Agency further reserves the right to cancel the Notice of Intent to Award at any time prior to the execution of a written contract.

2.26 Review of Notice of Disqualification or Notice of Intent to Award Decision.

Bidders may request reconsideration of either a notice of disqualification or notice of intent to award decision by submitting a written request to the Agency:

The Agency must receive the written request for reconsideration within five calendar days of the date of either a disqualification notice or a notice of intent to award, exclusive of Saturdays, Sundays, and legal state holidays. The written request may be emailed or delivered by postal service or other shipping service. Do not deliver any requests for reconsideration to the office in person. It is the Bidder's responsibility to ensure that the request for reconsideration is received prior to the deadline. Postmarking or submission to a shipping service by the due date shall not substitute for actual receipt of a request for reconsideration by the Agency.

The request for reconsideration shall clearly and fully identify all issues being contested by reference to the page and section number of the RFP. If a Bidder submitted multiple Proposals and requests that the Agency reconsider a notice of disqualification or notice of intent to award decision for more than one Proposal, a separate written request shall be submitted for each. At the Agency's discretion, requests for reconsideration from the same Bidder may be reviewed separately or combined into one response. The Agency will expeditiously address the request for reconsideration and issue a decision. The Bidder may choose to file an appeal with the Agency within five calendar days of the date of the decision on reconsideration, exclusive of Saturdays, Sundays, and legal state holidays, and in accordance with 441 lowa Admin. Code Ch. 7.

2.27 Definition of Contract.

The full execution of a written contract shall constitute the making of a contract for services and no Bidder shall acquire any legal or equitable rights relative to the contract services until the contract has been fully executed by the apparent successful Bidder and the Agency.

2.28 Choice of Law and Forum.

This RFP and the resulting contract are governed by the laws of the State of Iowa without giving effect to the conflicts of law provisions thereof. Changes in applicable laws and rules may affect the negotiation and contracting process and the resulting contract. Bidders are responsible for ascertaining pertinent legal requirements and restrictions. Any and all litigation or actions commenced in connection with this RFP shall be brought and maintained in the appropriate Iowa forum.

2.29 Restrictions on Gifts and Activities.

lowa Code chapter 68B restricts gifts that may be given or received by state employees and requires certain individuals to disclose information concerning their activities with state government. Bidders must determine the applicability of this Chapter to their activities and comply with the requirements. In addition, pursuant to lowa Code § 722.1, it is a felony offense to bribe or attempt to bribe a public official.

2.30 Exclusivity.

Any contract resulting from this RFP shall not be an exclusive contract.

2.31 No Minimum Guaranteed.

The Agency anticipates that the selected Bidder will provide services as requested by the Agency. The Agency does not guarantee that any minimum compensation will be paid to the Bidder or any minimum usage of the Bidder's services.

2.32 Use of Subcontractors.

The Agency acknowledges that the selected Bidder may contract with third parties for the performance of any of the Contractor's obligations. The Agency reserves the right to provide prior approval for any subcontractor used to perform services under any contract that may result from this RFP.

2.33 Bidder Continuing Disclosure Requirement.

To the extent that Bidders are required to report incidents when responding to this RFP related to damages, penalties, disincentives, administrative or regulatory proceedings, founded child or dependent adult abuse, or felony convictions, these matters are subject to continuing disclosure to the Agency. Incidents occurring after submission of a Bid Proposal, and with respect to the successful Bidder after the execution of a contract, shall be disclosed in a timely manner in a written statement to the Agency. For purposes of this subsection, timely means within thirty (30) calendar days from the date of conviction, regardless of appeal rights.

Files shall be text-based and not scanned image(s) and shall be searchable and not password protected or contain restrictions that prevent copying, saving, highlighting, or printing of the contents.

3.2 Contents and Organization of Technical Proposal.

This section describes the information that must be in the Technical Proposal. Bid Proposals should be organized into sections **in the same order provided here**. Bid Proposals should use tabs to separate each section. If a Bidder chooses to provide information in attachments to respond to any section below, please create a new tabbed attachment section immediately behind the applicable section. For example, to add attachments related to information asked for in Section 3.2.3 Information to Include Behind Tab 3: Bidder's Approach to Meeting Deliverables, the Bidder would create a new tab in the Technical Proposal that is called Tab 3 Attachments and place the attachment(s) there. The Bidder would follow suit by creating new tabbed sections for attachments created to respond to any other section below in their bid proposal.

3.2.1 Information to Include Behind Tab 1: Transmittal Letter.

The transmittal letter serves as a cover letter for the Technical Proposal. It must consist of an executive summary that briefly reviews the strengths of the Bidder and key features of its proposed approach to meet the specifications of this RFP.

3.2.2 Information to Include Behind Tab 2: Proposal Table of Contents.

The Bid Proposal must contain a table of contents.

3.2.3 Information to Include Behind Tab 3: Bidder's Approach to Meeting Deliverables.

The Bidder shall address each deliverable that the successful contractor will perform as listed in Section 1.3, Scope of Work, by first restating the Deliverable from the RFP and then detailing the Bidder's planned approach to meeting each contractor Deliverable immediately after restated text. Bid responses should provide sufficient detail so that the Agency can understand and evaluate the Bidder's approach and should not merely repeat the Deliverable.

Bidders are given wide latitude in the degree of detail they offer or the extent to which they reveal plans, designs, examples, processes, and procedures. Bidders do not need to address any responsibilities that are specifically designated as Agency responsibilities.

Note:

• Responses to Deliverables shall be in the same sequence as presented in the RFP. Bid Proposals shall identify any deviations from the specifications the Bidder cannot satisfy. Bid Proposals shall not contain promotional or display materials unless specifically required.

If a Bidder proposes more than one method of meeting the RFP requirements, each method must be drafted and submitted as separate Bid Proposals. Each evaluated separately.

The Bidder shall also include the following documents:

3.2.3.1 Attachment G: List of Financial Institutions and Real Property Resources

A list of the FIs and real property asset resources that the Bidder connects with and receives data from shall be submitted using the workbook set forth in Attachment G of this RFP. Bidders should submit an Excel version of Attachment G.

- A. Bidders shall list the name of the entity in Column B.
- B. Bidders shall identify if the entities listed in Column B are an lowa based entity by placing an X in column C or an out-of-state entity by placing an X in column D.

3.2.3.2 Attachment H: Bidder Proposal Form

The Bidder Proposal Form shall be submitted using the form set forth in Attachment H of this RFP.

- A. Bid Proposal Form and related exhibits or attachments shall not contain promotional or display materials unless specifically required.
- B. Bidder responses to questions should provide sufficient detail so that the Agency can understand and evaluate the Bidder's approach.
- C. Bidders are given wide latitude in the degree of detail they offer or the extent to which they reveal plans, designs, examples, processes, and procedures.

3.2.3.3 Special Submissions

The Bidder should also provide behind Tab 3 draft project work plans detailing activities and timelines, that include:

- A. Transition Plan
- B. Systems Implementation Plan
- C. Operations Plan
- D. Reporting Plan

3.2.4 Information to Include Behind Tab 4: Bidder's Experience.

3.2.4.1 Technical Experience

State the level of technical experience by providing the types of services sought by the RFP.

3.2.4.2 Previous Experience

List description of all services similar to those sought by this RFP that the Bidder has provided to the Agency and other businesses or governmental entities within the last twenty-four (24) months. For each similar service, provide a matrix detailing:

- A. Project title;
- B. Project role (primary contractor or subcontractor);
- C. Name of client agency or business;
- D. General description of the scope of work;
- E. Start and end dates of contract for services as originally entered into between the parties;
- F. If the contract was terminated for any reason before completion of all obligations under the contract provisions, detail the reason(s) for the termination;
- G. Contract value;
- H. Whether the services were provided timely and within budget;
- I. Any damages, penalties, disincentives assessed, or payments withheld, or anything of value traded or given up by the Bidder that were valued at or above \$500,000. Include the estimated cost assessed against the Bidder for the incident with the details of the occurrence;
- *J.* List administrative or regulatory proceedings or adjudicated matters related to this service to which the Bidder has been a party;
- K. Whether the Bidder has been debarred or suspended from federally funded healthcare programs by any state or the federal government; and
- L. Contact information for the client's project manager including address, telephone number, and email address.

3.2.4.3 Letters of Reference

Provide Letters of Reference from three (3) of the Bidder's previous clients knowledgeable of the Bidder's performance in providing services similar to those sought in this RFP, including a contact person, telephone number, and email address for each reference. It is preferred that letters of reference are provided for services that were procured in a competitive environment. Form letters of reference that do not elaborate on the Bidder's performance under the specific relationships addressed in the reference letter may negatively impact the Bidder's evaluation/score. Persons who are currently employed by the Agency are not eligible to be references.

3.2.4.4 Subcontractor Management

Provide a description of experience managing subcontractors, if the Bidder proposes to use subcontractors.

Section 4 Evaluation Of Bid Proposals

4.1 Introduction.

This section describes the evaluation process that will be used to determine which Bid Proposal provides the greatest benefit to the Agency. When making this determination, the Agency will not necessarily award a contract to the Bidder offering the lowest cost to the Agency or to the Bidder with the highest point total. Rather, a contract will be awarded to the Bidder that offers the greatest benefit to the Agency.

4.2 Evaluation Committee.

The Agency intends to conduct a comprehensive, fair, and impartial evaluation of Bid Proposals received in response to this RFP. In making this determination, the Agency will be represented by an evaluation committee.

4.3 Proposal Scoring and Evaluation Criteria.

The evaluation committee will use the method described in this section to assist with initially determining the relative merits of each Bid Proposal.

4.3.1 Scoring Guide.

Points will be assigned to each evaluation component as follows, unless otherwise designated:

4	Bidder has agreed to comply with the requirements and provided a clear and compelling description of how each requirement would be met, with relevant supporting materials. Bidder's proposed approach frequently goes above and beyond the minimum requirements and indicates superior ability to serve the needs of the Agency.
3	Bidder has agreed to comply with the requirements and provided a good and complete description of how the requirements would be met. Response clearly demonstrates a high degree of ability to serve the needs of the Agency.
2	Bidder has agreed to comply with the requirements and provided an adequate description of how the requirements would be met. Response indicates adequate ability to serve the needs of the Agency.
1	Bidder has agreed to comply with the requirements and provided some details on how the requirements would be met. Response does not clearly indicate if all the needs of the Agency will be met.
0	Bidder has not addressed any of the requirements or has provided a response that is limited in scope, vague, or incomplete. Response did not provide a description of how the Agency's needs would be met.

4.3.2 Technical Proposal Components.

When Bid Proposals are evaluated, the total points for each component are comprised of the component's assigned weight multiplied by the score the Bid Proposal earns. Points for all components will be added together. The evaluation components, including maximum points that may be awarded, are as follows:

4.3.3 Scoring of Cost Proposal Pricing.

Attachment F: Cost Proposal pricing will be the amount listed as the "Grand Total for the Entire Project". Cost Proposal pricing will be scored based on a ratio of the lowest Cost Proposal versus the cost of each higher priced Bid Proposal. Under this formula, the lowest Cost Proposal receives all the points assigned to pricing. A Cost Proposal twice as expensive as the lowest Cost Proposal would earn half of the available points. The formula is:
