

NOTICE-TO-BIDDERS

GRU881507A Nutrient Reduction Wetland Project Section 07, Township 88 North, Range 15 West Grundy County, Iowa

Sealed bids will be received by the Iowa Department of Agriculture & Land Stewardship, Division of Soil Conservation and Water Quality (Division), 502 East 9th Street, Des Moines, Iowa, 50319, until 3:00 PM local time, on Thursday, March 16, 2023, and opened at a public meeting and read aloud on March 16, 2023, 3:00 PM. The bid opening will be held in the Wallace Building. Interested parties may call in to hear the bid opening using teleconference call-in number: 1-877-304-9269 access code 519321. Bids must be submitted on the appropriate bid forms provided and shall include a bid bond in the amount of ten percent (10%). Bidders must also be registered with the Iowa Division of Labor.

In general, the work involves, but is not limited to, selective clearing, excavation, grading, aluminum toe-wall installation, tile installation, CMP water control structure, and seeding. This project includes around 5,844 cubic yards of earthwork, one aluminum toe-wall, 915 linear feet of tile installation, 251 tons of riprap or erosion stone, and 2.5 acres of seeding. The estimated construction cost range for this project is \$150,000 to \$180,000.

A pre-bid conference will be held at Grundy Center USDA Service Center – NRCS, 805 W 4th ST, Grundy, IA 50638-1069, at 10:00 AM on Thursday, March 2, 2023, telephone:319-824-3634. Attendance at the pre-bid conference by prospective bidders is not mandatory but is encouraged.
