The Iowa Department of Public Defense, on behalf of the Iowa National Guard (IANG), will be receiving sealed bids until **11:30 A.M.** local time at the WATERLOO AASF READINESS CENTER CLASSROOM, 2245 WEST BIG ROCK RD, WATERLOO, IA 50703 for the proposed WATERLOO AASF FLOORING AND LED LIGHTING, WATERLOO, IOWA. The general scope of work includes, but is not limited to:

Base Bid: Removal of existing epoxy flooring and sealants, patching of all floor cracks, new epoxy flooring and sealants in Aircraft Hangar (approximately 26,800 sf) and in Allied Trades (approximately 1,510 sf), new safety striping to match existing layout, and replacement of existing lighting with new high-efficiency LED lighting in the Aircraft Hangars and Allied Trades room.

Alternate Bid No.1: Replace existing site lighting with new high-efficiency LED lighting.

Bids received will be opened and read aloud at the time and place stated. Late bids will not be considered. Bids must be hand-delivered (bids received via mail, delivery service, oral, telephonic, facsimile or other electronically transmitted bids will not be accepted). Interested parties are invited to attend.

Bids shall be submitted on the Bid Form and shall be accompanied by a Bid Security as set forth in the Instructions to Bidders in the amount of five percent (5%) of the total bid amount. Each bid shall be accompanied by a bid bond executed by corporations authorized to contract as surety in Iowa, cashier's check or a certified check drawn upon a solvent bank chartered under the laws of the United States of America, made payable to Iowa Department of Public Defense; as a guarantee that the accepted bidder shall enter into a contract with the State of Iowa and file an approved surety company Performance and Payment Bond for the faithful performance thereof. Upon failure to comply, said check or bid bond shall become forfeited as liquidated damages.

Any construction contractor performing work in Iowa (including out-of-state contractors) must comply with Chapter 91C of Iowa Code

Bidders must comply with all affirmative action/equal employment opportunity provisions of the State of Iowa and the Federal Government. The Iowa Department of Public Defense, Iowa Army National Guard, seeks to provide opportunities for Targeted Small Businesses in accordance with the provisions of Chapter 73 of the Code of Iowa. their complete set of Bidding Documents, including any addenda, properly bound and in good condition to Beeline and Blue within 14 calendar days after opening of bids. Cash deposits will not be accepted.
