RFP Purpose.

The purpose of the RFP is to solicit proposals that will enable the Department of Human Services (Agency) to select the most qualified contractor to provide business services to regulated child care providers in the State. The contractor will provide training, coaching and technical assistance on effective business practices to both center and home-based settings to support operation of sustainable child care businesses that provide quality child care services to Iowa's families.

Duration of Contract.

The Agency anticipates executing a contract that will have an initial 1 year contract term with the ability to extend the contract for 5 additional 1-year terms. The Agency will have the sole discretion to extend the contract.

Procurement Timetable

There are no exceptions to any deadlines for the Bidder; however, the Agency reserves the right to change the dates. Times provided are in Central Time.

Section 1 Background and Scope of Work

1.1 Background.

The Agency is responsible for administration of the Child Care Development Fund (CCDF), which provides federal funding to states to support child care services for low-income children and improve the development of participating children. CCDF regulations require the Agency to implement strategies to strengthen the business practices of child care providers to expand the supply, and improve the quality of child care services.

1.2 RFP General Definitions.

When appearing as capitalized terms in this RFP, including attachments, the following quoted terms (and the plural thereof, when appropriate) have the meanings set forth in this section.

“Agency” means the Iowa Department of Human Services.

“Bid Proposal” or **“Proposal”** means the Bidder’s proposal submitted in response to the RFP.

“Bidder” means the entity that submits a Bid Proposal in response to this RFP.

“Contractor” means the Bidder who enters into a Contract as a result of this Solicitation.

“Deliverables” means all of the services, goods, products, work, work product, data (including data collected on behalf of the Agency), items, materials and property to be created, developed, produced, delivered, performed, or provided by or on behalf of, or made available through, the Contractor (or any agent, contractor or subcontractor of the Contractor) in connection with any contract resulting from this RFP.

“Invoice” means a Contractor’s claim for payment. At the Agency’s discretion, claims may be submitted on an original invoice from the Contractor or may be submitted on a claim form accepted by the Agency, such as a General Accounting Expenditure (GAX) form.

Definitions Specific to this RFP.

When appearing as capitalized terms in this RFP, including attachments, the following quoted terms (and the plural thereof, when appropriate) have the meanings set forth in this section.

“Approved Professional Development Organization” means an organization that is approved by the Agency to provide professional development hours for regulated child care staff. More information can be found at <https://dhs.iowa.gov/licensure-and-registration/tools-trainings-and-resources>

“Child Care Center Administrator(s)” means the individual(s) responsible for administration of a licensed child care center.

“CCR&R Regions” means the five geographical regions of Iowa Child Care Resource and Referral. These regions can be found in Attachment F.

“Child Development Home (CDH) Administrator” means the individual who was approved for registration as a CDH and is responsible for the administration of that CDH.

“Coaching” means a form of Technical Assistance as defined by the National Association for the Education of Young Children (NAEYC) and Child Care Aware as a relationship-based process led by an expert with specialized and adult learning knowledge and skills, who often serves in a different professional role than the recipient(s). Coaching is designed to build capacity for specific professional dispositions, skills, and behaviors and is focused on goal-setting and achievement for an individual or group. “Cost Per Child” means the cost to the child care program to provide services per child.

“Early Childhood Iowa” means the statewide initiative in which the state and local communities need to work together to improve the efficiency and effectiveness of early care, education, health, and human services provided to families with children zero through age five. The initiative consists of three main parts: the state leadership board, the state advisory structure and local areas structure. “Enrollment Percentage” means the percentage of child care spots available in a particular child care program in which a child has been enrolled.

“Iowa Child Care Resource & Referral (CCR&R) Agencies” means the community-based agencies staffed by early care and education professionals that work to build the supply of quality child care options in local communities, connect families with quality child care services and provide on-site consultation and assistance to child care providers.

“Iowa Quality for Kids (IQ4K)” means Iowa’s voluntary child care rating system for Child Development Homes, licensed child care centers/preschools, and child care programs that are operated by school districts. The quality rating and improvement system was developed to raise the quality of child care in Iowa, increase the number of children in high-quality child care settings, and educate parents about quality in child care. “Iron Triangle” means the interaction between three factors that are important in balancing early childhood program budgets: Cost Per Child, Enrollment Percentage and Revenue Collected.

“Revenue Collected” means the collection of the fees due to a program for early childhood services provided to a child.

“Technical Assistance (TA)” means the provision of targeted and customized supports by a professional(s) with subject matter and adult learning knowledge and skills to develop or strengthen processes, knowledge application, or implementation of services by recipients. 1.3 Scope of Work.

1.3.1 Deliverables.

1.3.1(A) The Contractor shall provide the following business services for child care centers.

1. The Contractor shall own or have permission from the curriculum developer to offer a training series for child care center staff that meets the following requirements:
 - a. Is at least 10 hours so as to meet the new requirement in IQ4K regarding training in leadership, administration or management.
 - b. Must cover the following topics:
 - i. Record keeping, including what records should be kept and the timeframes that they should be kept for;
 - ii. Procedures for tracking key fiscal measures including Cost Per Child, Revenue Collected, Enrollment Percentage and cash flow;

- iii. Budgeting, including but not limited to projecting revenues and costs, potential sources of income and planning based on a budget;
 - iv. Procedures for adjusting program operations based on tracking of key fiscal measures;
 - v. Liabilities and risk management;
 - vi. Staff recruitment and retention; and
 - vii. Marketing, including a variety of methods and formats.
 - c. Includes a pre- and post-assessment of provider knowledge of effective business practices covered in the training
2. The Contractor shall offer the training described in 1.3.1(A)1 at least four times each year and in a manner that Child Care Center Administrators in all CCR&R Regions have equitable access to the training.
3. The Contractor shall implement and use an evidence-based Coaching model, (e.g. practice based coaching) to coordinate with and support implementation of best practices contained within the training described in 1.3.1(A)1.
 - a. Participants who finish the training described in 1.3.1(A)1 shall be eligible for Coaching.
 - b. Coaching shall be provided on a monthly basis for at least one year unless the participant requests to discontinue Coaching.
 - c. The Contractor shall develop a Coaching agreement outlining responsibilities of the Contractor's Coaching staff and the Coaching participants. The Agency must approve the agreement before use and all participants must sign the agreement before participating in Coaching.
 - d. The Contractor shall recruit 15% of eligible participants into Coaching. If more than 15% of participants would like to participate in Coaching, the Contractor shall obtain Agency approval of the development and implementation of a prioritization process as needed.
4. The Contractor shall do a one year follow-up assessment for all Child Care Center Administrators who have finished the training described in 1.3.1(A)1. The follow-up assessment shall evaluate which of the business practices covered in the training are being implemented by the Child Care Center Administrator.
5. The Contractor shall provide Technical Assistance (TA) as requested by participants who attend the training described in 1.3.1(A)1. TA may be provided in-person or through the use of technology (e.g. phone, video conferencing, etc...).

1.3.1(B) The Contractor shall provide the following business services for Child Development Homes.

1. The Contractor shall own or have permission from the curriculum developer to offer a training series for child development home staff that meets the following requirements:
 - a. Is at least 10 hours.
 - b. Must cover the following topics:
 - i. Record keeping, including what records should be kept and the timeframes that they should be kept for;
 - ii. Procedures for tracking key fiscal measures including Cost Per Child, Revenue Collected, Enrollment Percentage and cash flow;
 - iii. Budgeting, including but not limited to projecting revenues and costs, potential sources of income and planning based on a budget;
 - iv. Procedures for adjusting program operations based on tracking of key fiscal measures;
 - v. Liabilities and risk management;
 - vi. Staff recruitment and retention, including substitutes and assistants that meet Iowa CDH regulatory requirements; and
 - vii. Marketing, including a variety of methods and formats.
 - c. Includes a pre- and post-assessment of provider knowledge of effective business practices covered in the training
2. The Contractor shall offer the training described in 1.3.1(B)1 at least four times each year and in a manner that Child Development Home Administrators in all CCR&R Regions have equitable access to the training.

3. The Contractor shall implement and use an evidence-based Coaching model, (e.g. practice based coaching) to coordinate with and support implementation of best practices contained within the training described in 1.3.1(B)1.
 - a. Participants who finish the training described in 1.3.1(B)1 shall be eligible for Coaching.
 - b. Coaching shall be provided on a monthly basis for at least one year unless the participant requests to discontinue Coaching.
 - c. The Contractor shall develop a Coaching agreement outlining responsibilities of the Contractor's Coaching staff and the participant participating in the Coaching. The Agency must approve the agreement before use and all participants must sign the agreement before participating in Coaching.
 - d. The Contractor shall recruit at minimum 15% of eligible participants into Coaching. If more than 15% of participants would like to participate in Coaching, the Contractor shall obtain Agency approval of the development and implementation of a prioritization process as needed.
4. The Contractor shall do a one year follow-up assessment for all Child Development Home Administrators who have finished the training described in 1.3.1(B)1. The follow-up assessment shall evaluate which of the business practices covered in the training are being implemented by the Child Development Home Administrator.
5. The Contractor shall provide Technical Assistance (TA) as requested by participants who attend the training described in 1.3.1(B)1. TA may be provided in-person or through the use of technology (e.g. phone, video conferencing, etc.).

1.3.1(C) The Contractor shall provide the following general statewide services.

1. The Contractor shall be or become an Approved Professional Development Organization within three months of contract execution, and shall not let this approval expire throughout the duration of the Contract.
2. The Contractor shall collaborate with other organizations in the state that have activities focused on improving business practices of child care programs. This includes but is not limited to CCR&R and Iowa Women's Foundation.
3. The Contractor shall represent the business needs of child care programs in the Early Childhood Iowa state system through active participation in Stakeholders Alliance and/or component groups.
4. The Contractor shall seek public and private funding from sources other than the Agency to support the business needs of child care programs in the State of Iowa.
5. The Contractor shall provide TA to Agency regulatory staff as requested by individual Agency regulatory staff or the Agency's Child Care Bureau staff. Contractor shall respond to TA requests from Agency staff within two business days.
6. The Contractor shall provide TA to CCR&R staff as requested through a process developed in collaboration with the Agency's Program Manager for CCR&R and approved by the Agency.

1.3.1(D) Reporting Requirements

1. The Contractor shall keep adequate records to report the following information on a quarterly basis:
 - a. Dates, format (e.g. on-line, in-person or blended) and if applicable physical location of all trainings offered through the Contract.
 - b. Number of participants that attended each session in the series described in 1.3.1(A)1 and 1.3.1(B)1.
 - c. Number of participants that completed the series described in 1.3.1(A)1 and 1.3.1(B)1.
 - d. Pre- and Post-assessment scores of participants that completed the series described in 1.3.1(A)1 and 1.3.1(B)1.
 - e. Number of eligible participants that are participating in Coaching.
 - f. Number of Coaching visits done per month and time spent preparing for and conducting those visits.
 - g. Results of one-year follow-up described in 1.3.1(A)4 and 1.3.1(B)4. Contractor must be able to separate data out by those that participated in Coaching and those that did not.

- h. Number of technical assistance contacts and topics discussed. Contractor must be able to separate data by training participant, Agency staff and CCR&R staff.
 - i. ECI state system meetings attended.
 - j. Narrative describing other sources of funding sought.
2. Quarterly Reports will be due on the following dates:
- Quarter 1 (July-September): October 31
 - Quarter 2 (October-December): January 31
 - Quarter 3 (January-March): April 30
 - Quarter 4 (April-June): July 31

1.3.2 Performance Measures.

The Contractor shall meet the following performance measures:

1. 80% of participants who finish the training described in 1.3.1(A)1 and 1.3.1(B)1 will show an increase in knowledge from pre-assessment to post-assessment.
2. 80% of participants who finish the training described in 1.3.1(A)1 and 1.3.1(B)1 that are still in the field in one year will complete the follow-up.
3. 50% of participants who complete the follow-up will be implementing at least 50% of the business practices covered in the training described in 1.3.1(A)1 and 1.3.1(B)1.
4. 80% of Agency staff that receive TA from the Contractor will be satisfied with TA provided.
5. A minimum of 15% of all eligible Child Care Center Administrators shall participate in Coaching.
6. A minimum of 15% of all eligible Child Development Home Administrators shall participate in Coaching.
7. 100% of all reporting requirements described in section 1.3.1 D shall be met.

1.3.3 Contract Payment Methodology.

The Agency will pay the Contractor monthly in accordance with an annually negotiated budget and upon receipt of an invoice for services provided. The total Contract value shall not exceed \$1,500,000 over the life of the Contract.

Section 2 Basic Information About the RFP Process

2.1 Issuing Officer.

2.2 Restriction on Bidder Communication.

From the issue date of this RFP until announcement of the successful Bidder, the Issuing Officer is the point of contact regarding the RFP. There may be no communication regarding this RFP with any State employee other than the Issuing Officer, except at the direction of the Issuing Officer or as otherwise noted in the RFP. This section shall not be construed as restricting communications related to the administration of any contract currently in effect between a Contractor and the Agency.

The Issuing Officer will respond only to questions regarding the procurement process. Questions pertaining to the interpretation of this RFP may be submitted in accordance with the Questions, Requests for Clarification, and Suggested Changes section of this RFP.

2.3 Downloading the RFP from the Internet.

The RFP and any related documents such as amendments or attachments (collectively the “RFP”), and responses to questions will be posted at the State of Iowa’s website for bid opportunities: <http://bidopportunities.iowa.gov/>. Check this website periodically for any amendments to this RFP. The posted version of the RFP is the official version. The Agency will only be bound by the official version of the RFP document(s). Bidders should ensure that any downloaded documents are in fact the most up to date and are unchanged from the official version.

2.5 Intent to Bid.

The Agency requests that Bidders provide their intent to bid to the Issuing Officer by the date and time in the Procurement Timetable. Email is the preferred delivery method. The intent to bid should include the Bidder's name, contact person, mailing address, email address, fax number, telephone number, and a statement of intent to submit a bid in response to this RFP. Though it is not mandatory that the Agency receive an intent to bid, the Agency will only respond to questions about the RFP that have been submitted by Bidders who have expressed their intent to bid. The Agency may cancel an RFP for lack of interest based on the number of letters of intent to bid received.

2.6 Bidders' Conference.

The Bidders' conference will be conducted as a conference call on the date and time listed in the Procurement Timetable. The purpose of the Bidders' conference is to inform prospective Bidders about the work to be performed and to provide prospective Bidders an opportunity to ask questions regarding the RFP. Verbal discussions at the conference shall not be considered part of the RFP unless incorporated into the RFP by amendment. Questions asked at the conference that cannot be adequately answered during the conference may be deferred and responded to in writing. Participation in this conference call is optional, but recommended as this will be the only opportunity to ask verbal questions regarding this RFP.

2.7 Questions, Requests for Clarification, and Suggested Changes.

Bidders who have provided their intent to bid on the RFP are invited to submit written questions, requests for clarifications, and/or suggestions for changes to the specifications of this RFP (hereafter "Questions") by the due date and time provided in the Procurement Timetable. Bidders are not permitted to include assumptions in their Bid Proposals. Instead, Bidders shall address any perceived ambiguity regarding this RFP through the question and answer process. If the Questions pertain to a specific section of the RFP, the page and section number(s) must be referenced. The Agency prefers to receive Questions by email. The Bidder may wish to request confirmation of receipt from the Issuing Officer to ensure delivery.

Written responses to questions will be posted at <http://bidopportunities.iowa.gov/> by the date provided in the Procurement Timetable.

The Agency assumes no responsibility for verbal representations made by its officers or employees unless such representations are confirmed in writing and incorporated into the RFP. In addition, the Agency's written responses to Questions will not be considered part of the RFP. If the Agency decides to change the RFP, the Agency will issue an amendment.

2.8 Submission of Bid Proposal.

All bid proposal submissions shall be mailed to the attention of the issuing officer. Electronic transmissions and/or in-person delivery of bid proposal submissions shall not be accepted. Each Bidder is responsible for ensuring that the Issuing Officer receives the Bid Proposal by the time and date specified in the Procurement Timetable at the address provided in the RFP for the Issuing Officer. The Agency will not waive this mandatory requirement. Any Bid Proposal received after this deadline will be rejected and will not be evaluated.

Bid Proposals are to be submitted in accordance with the Bid Proposal Formatting section of this RFP. Bidders shall allow ample mail delivery time to ensure timely receipt of their Bid Proposals. It is the Bidder's responsibility to ensure that the Bid Proposal is received prior to the deadline. Postmarking or submission to a courier by the due date shall not substitute for actual receipt of the Bid Proposal by the Agency.

2.9 Amendment to the RFP and Bid Proposal.

Each Bidder is responsible for ensuring that the Issuing Officer receives the Bid Proposal and any permitted amendments by the established deadlines at the address provided in the RFP for the Issuing Officer.

Bidders may amend a previously submitted Bid Proposal at any time before the bid submission date and time. Any such amendment must be in writing and signed by the Bidder. The Bidder shall provide the same number of copies of the amended Bid Proposal as is required for the original Bid Proposal, for both hardcopy and electronic copies, in accordance with the Bid Proposal Formatting Section.

The Agency reserves the right to amend or provide clarifications to the RFP at any time. RFP amendments will be posted to the State's website at <http://bidopportunities.iowa.gov/>. If an RFP amendment occurs after the

closing date for receipt of Bid Proposals, the Agency may, in its sole discretion, allow Bidders to amend their Bid Proposals.

2.10 *Withdrawal of Bid Proposal.*

The Bidder may withdraw its Bid Proposal prior to the closing date for receipt of Bid Proposals by submitting a written request to withdraw to the Issuing Officer. Email and faxed requests to withdraw will not be accepted.

2.11 *Costs of Preparing the Bid Proposal.*

The costs of preparation and delivery of the Bid Proposal are solely the responsibility of the Bidder.

2.12 *Rejection of Bid Proposals.*

The Agency reserves the right to reject any or all Bid Proposals, in whole and in part, and to cancel this RFP at any time prior to the execution of a written contract. Issuance of this RFP in no way constitutes a commitment by the Agency to award or enter into a contract.

2.13 *Review of Bid Proposals.*

Only Bidders that meet the mandatory requirements and are not subject to disqualification will be considered for award of a contract.

2.13.1 *Mandatory Requirements.*

Bidders must meet these mandatory requirements or will be disqualified and not considered for award of a contract:

- The Issuing Officer must receive the Bid Proposal, and any amendments thereof, prior to or on the due date and time (See RFP Sections 2.8 and 2.9).
- The Bidder is not presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from receiving federal funding by any federal department or agency (See RFP Additional Certifications Attachment).
- The Bidder's Cost Proposal adheres to any pricing restrictions regarding the project budget or administrative costs (See RFP Section 3.3).

2.13.2 *Reasons Proposals May be Disqualified.*

Bidders are expected to follow the specifications set forth in this RFP. However, it is not the Agency's intent to disqualify Bid Proposals that suffer from correctible flaws. At the same time, it is important to maintain fairness to all Bidders in the procurement process. Therefore, the Agency reserves the discretion to permit cure of variances, waive variances, or disqualify Bid Proposals for reasons that include, but may not be limited to, the following:

- Bidder initiates unauthorized contact regarding this RFP with employees other than the Issuing Officer (See RFP Section 2.2);
- Bidder fails to comply with the RFP's formatting specifications so that the Bid Proposal cannot be fairly compared to other bids (See RFP Section 3.1);
- Bidder fails, in the Agency's opinion, to include the content required for the RFP;
- Bidder fails to be fully responsive in the Bidder's Approach to Meeting Deliverables Section, states an element of the Scope of Work cannot or will not be met, or does not include information necessary to substantiate that it will be able to meet the Scope of Work specifications (See RFP Section 3.2.3);
- Bidder's response materially changes Scope of Work specifications;
- Bidder fails to submit the RFP attachments containing all signatures (See RFP Section 3.2.6);
- Bidder marks entire Bid Proposal confidential, makes excessive claims for confidential treatment, or identifies pricing information in the Cost Proposal as confidential (See RFP Section 3.1);
- Bidder includes assumptions in its Bid Proposal (See RFP Section 2.7); or

- Bidder fails to respond to the Agency's request for clarifications, information, documents, or references that the Agency may make at any point in the RFP process.
- Bidder is a "scrutinized company" included on a "scrutinized company list" created by a public fund pursuant to Iowa Code §12J.3. This list is maintained by the Iowa Public Employees' Retirement System. The list is currently found here: <https://www.ipers.org/about-us/investments/restrictions-regarding-companies-boycotting-israel#main-content>.

The determination of whether or not to disqualify a proposal and not consider it for award of a contract for any of these reasons, or to waive or permit cure of variances in Bid Proposals, is at the sole discretion of the Agency. No Bidder shall obtain any right by virtue of the Agency's election to not exercise that discretion. In the event the Agency waives or permits cure of variances, such waiver or cure will not modify the RFP specifications or excuse the Bidder from full compliance with RFP specifications or other contract requirements if the Bidder enters into a contract.

2.14 Bid Proposal Clarification Process.

The Agency may request clarifications from Bidders for the purpose of resolving ambiguities or questioning information presented in the Bid Proposals. Clarifications may occur throughout the Bid Proposal evaluation process. Clarification responses shall be in writing and shall address only the information requested. Responses shall be submitted to the Agency within the time stipulated at the occasion of the request.

2.15 Verification of Bid Proposal Contents.

The contents of a Bid Proposal submitted by a Bidder are subject to verification.

2.16 Reference Checks.

The Agency reserves the right to contact any reference to assist in the evaluation of the Bid Proposal, to verify information contained in the Bid Proposal, to discuss the Bidder's qualifications, and/or to discuss the qualifications of any subcontractor identified in the Bid Proposal.

2.17 Information from Other Sources.

The Agency reserves the right to obtain and consider information from other sources concerning a Bidder, such as the Bidder's capability and performance under other contracts, and the Bidder's authority and ability to conduct business in the State of Iowa. Such other sources may include subject matter experts.

2.18 Criminal History and Background Investigation.

The Agency reserves the right to conduct criminal history and other background investigations of the Bidder, its officers, directors, shareholders, or partners and managerial and supervisory personnel retained by the Bidder for the performance of the resulting contract. The Agency reserves the right to conduct criminal history and other background investigations of the Bidder's staff and subcontractors providing services under the resulting contract.

2.19 Disposition of Bid Proposals.

Opened Bid Proposals become the property of the Agency and will not be returned to the Bidder. Upon issuance of the Notice of Intent to Award, the contents of all Bid Proposals will be in the public domain and be open to inspection by interested parties subject to exceptions provided in Iowa Code chapter 22 or other applicable law.

2.20 Public Records and Request for Confidential Treatment.

Original information submitted by a Bidder may be treated as public information by the Agency following the conclusion of the selection process unless the Bidder properly requests that information be treated as confidential at the time of submitting the Bid Proposal. See the Bid Proposal Formatting Section for the proper method for making such requests. The Agency's release of information is governed by Iowa Code chapter 22. Bidders are encouraged to familiarize themselves with Chapter 22 before submitting a Bid Proposal. The Agency will copy public records as required to comply with public records laws.

The Agency will treat the information marked confidential as confidential information to the extent such information is determined confidential under Iowa Code chapter 22 or other applicable law by a court of competent jurisdiction. However, the Bidder shall certify by signing and returning RFP Attachment B its understanding that any Agency references to Bid Proposal information marked confidential made during the evaluation process may become part of the public domain

In the event the Agency receives a request for information marked confidential, written notice shall be given to the Bidder seventy-two (72) hours prior to the release of the information to allow the Bidder to seek injunctive relief pursuant to Iowa Code § 22.5 or 22.8.

The Bidder's failure to request confidential treatment of material pursuant to this section and the relevant law will be deemed, by the Agency and State personnel, as a waiver of any right to confidentiality that the Bidder may have had.

2.21 Copyrights.

By submitting a Bid Proposal, the Bidder agrees that the Agency may copy the Bid Proposal for purposes of facilitating the evaluation of the Bid Proposal or to respond to requests for public records. By submitting a Bid Proposal, the Bidder acknowledges that additional copies may be produced and distributed, and represents and warrants that such copying does not violate the rights of any third party. The Agency shall have the right to use ideas or adaptations of ideas that are presented in the Bid Proposals.

2.22 Release of Claims.

By submitting a Bid Proposal, the Bidder agrees that it shall not bring any claim or cause of action against the Agency based on any misunderstanding concerning the information provided herein or concerning the Agency's failure, negligent or otherwise, to provide the Bidder with pertinent information as intended by this RFP.

2.23 Reserved. (Presentations)

2.24 Notice of Intent to Award.

Notice of Intent to Award will be sent to all Bidders that submitted a Bid Proposal by the due date and time. The Notice of Intent to Award does not constitute the formation of a contract between the Agency and the apparent successful Bidder.

2.25 Acceptance Period.

The Agency shall make a good faith effort to negotiate and execute the contract. If the apparent successful Bidder fails to negotiate and execute a contract, the Agency may, in its sole discretion, revoke the Notice of Intent to Award and negotiate a contract with another Bidder or withdraw the RFP. The Agency further reserves the right to cancel the Notice of Intent to Award at any time prior to the execution of a written contract.

2.26 Review of Notice of Disqualification or Notice of Intent to Award Decision.

Bidders may request reconsideration of either a notice of disqualification or notice of intent to award decision by submitting a written request to the Agency:

The Agency must receive the written request for reconsideration within five days from the date of the notice of disqualification or notice of intent to award decision, whichever is earlier. The written request may be mailed,

emailed, or delivered. It is the Bidder's responsibility to assure timely delivery of the request for reconsideration. The request for reconsideration shall clearly and fully identify all issues being contested by reference to the page and section number of the RFP. If a Bidder submitted multiple Bid Proposals and requests that the Agency reconsider a notice of disqualification or notice of intent to award decision for more than one Bid Proposal, a separate written request shall be submitted for each. At the Agency's discretion, requests for reconsideration from the same Bidder may be reviewed separately or combined into one response. The Agency will expeditiously address the request for reconsideration and issue a decision. The Bidder may choose to file an appeal with the Agency within five days of the date of the decision on reconsideration in accordance with 441 IAC 7.41 et seq.

2.27 Definition of Contract.

The full execution of a written contract shall constitute the making of a contract for services and no Bidder shall acquire any legal or equitable rights relative to the contract services until the contract has been fully executed by the apparent successful Bidder and the Agency.

2.28 Choice of Law and Forum.

This RFP and the resulting contract are governed by the laws of the State of Iowa without giving effect to the conflicts of law provisions thereof. Changes in applicable laws and rules may affect the negotiation and contracting process and the resulting contract. Bidders are responsible for ascertaining pertinent legal requirements and restrictions. Any and all litigation or actions commenced in connection with this RFP shall be brought and maintained in the appropriate Iowa forum.

2.29 Restrictions on Gifts and Activities.

Iowa Code chapter 68B restricts gifts that may be given or received by state employees and requires certain individuals to disclose information concerning their activities with state government. Bidders must determine the applicability of this Chapter to their activities and comply with the requirements. In addition, pursuant to Iowa Code § 722.1, it is a felony offense to bribe or attempt to bribe a public official.

2.30 Exclusivity.

Any contract resulting from this RFP shall not be an exclusive contract.

2.31 No Minimum Guaranteed.

The Agency anticipates that the selected Bidder will provide services as requested by the Agency. The Agency does not guarantee that any minimum compensation will be paid to the Bidder or any minimum usage of the Bidder's services.

2.32 Use of Subcontractors.

The Agency acknowledges that the selected Bidder may contract with third parties for the performance of any of the Contractor's obligations. The Agency reserves the right to provide prior approval for any subcontractor used to perform services under any contract that may result from this RFP.

2.33 Bidder Continuing Disclosure Requirement.

To the extent that Bidders are required to report incidents when responding to this RFP related to damages, penalties, disincentives, administrative or regulatory proceedings, founded child or dependent adult abuse, or felony convictions, these matters are subject to continuing disclosure to the Agency. Incidents occurring after submission of a Bid Proposal, and with respect to the successful Bidder after the execution of a contract, shall be disclosed in a timely manner in a written statement to the Agency. For purposes of this subsection, timely means within thirty (30) days from the date of conviction, regardless of appeal rights.

If a Bidder chooses to provide information in attachments to respond to any section below, please create a new tabbed attachment section immediately behind the applicable section. For example, to add attachments related to information asked for in Section 3.2.3 Information to Include Behind Tab 3: Bidder’s Approach to Meeting Deliverables, the Bidder would create a new tab in the Technical Proposal that is called Tab 3 Attachments and place the attachment(s) there. The Bidder would follow suit by creating new tabbed sections for attachments created to respond to any other section below in their bid proposal

3.2.1 Information to Include Behind Tab 1:

Transmittal Letter.

The transmittal letter serves as a cover letter for the Technical Proposal. It must consist of an executive summary that briefly reviews the strengths of the Bidder and key features of its proposed approach to meet the specifications of this RFP.

3.2.2 Information to Include Behind Tab 2: Proposal Table of Contents.

The Bid Proposal must contain a table of contents.

3.2.3 Information to Include Behind Tab 3: Bidder’s Approach to Meeting Deliverables.

The Bidder shall address each Deliverable that the successful contractor will perform as listed in Section 1.3, Scope of Work, by first restating the Deliverable from the RFP and then detailing the Bidder’s planned approach to meeting each contractor Deliverable immediately after the restated text. Bid responses should provide

sufficient detail so that the Agency can understand and evaluate the Bidder's approach, and should not merely repeat the Deliverable.

Bidders are given wide latitude in the degree of detail they offer or the extent to which they reveal plans, designs, examples, processes, and procedures. Bidders do not need to address any responsibilities that are specifically designated as Agency responsibilities.

Note:

- Responses to Deliverables shall be in the same sequence as presented in the RFP.
- Bid Proposals shall identify any deviations from the specifications the Bidder cannot satisfy.
- Bid Proposals shall not contain promotional or display materials unless specifically required.

If a Bidder proposes more than one method of meeting the RFP requirements, each method must be drafted and submitted as separate Bid Proposals. Each will be evaluated separately.

3.2.4.3 Letters of reference from three (3) of the Bidder's previous clients knowledgeable of the Bidder's performance in providing services similar to those sought in this RFP, including a contact person, telephone number, and email address for each reference. It is preferred that letters of reference are provided for services that were procured in a competitive environment. Form letters of reference that do not elaborate on the Bidder's performance under the specific relationships addressed in the reference letter may negatively impact the Bidder's evaluation/score. Persons who are currently employed by the Agency are not eligible to be references.

3.2.4.4 Description of experience managing subcontractors, if the Bidder proposes to use subcontractors.

3.2.5 Information to Include Behind Tab 5: Personnel.

The Bidder shall provide the following information regarding personnel:

3.2.5.1 Tables of Organization.

Illustrate the lines of authority in two tables:

- One showing overall operations
- One showing staff who will provide services under the RFP

3.2.5.2 Names and Credentials of Key Corporate Personnel.

- Include resumes for all key corporate, administrative, and supervisory personnel who will be involved in providing the services sought by this RFP. The resumes should include: name, education, years of

experience, and employment history, particularly as it relates to the scope of services specified herein. Resumes shall not include social security numbers.

3.2.5.3 Information About Project Manager and Key Project Personnel.

The resumes shall include: name, education, and years of experience and employment history, particularly as it relates to the scope of services specified herein. Resumes should not include social security numbers.
- Include the project manager's experience managing subcontractor staff if the Bidder proposes to use subcontractors.

Pricing Restrictions.

Contract Budget.

The Agency is limiting the funding that is available for these services. Cost proposals may not exceed \$1,500,000.00 for the entire term of the Contract, including any contract extension years.

Content and Format.

The Bidder shall provide the following information in the Cost Proposal:

The bidder's Cost Proposal shall be submitted using the pricing worksheet set forth in Attachment G of this RFP.

Section 4 Evaluation Of Bid Proposals

4.1 Introduction.

This section describes the evaluation process that will be used to determine which Bid Proposal provides the greatest benefit to the Agency. When making this determination, the Agency will not necessarily award a contract to the Bidder offering the lowest cost to the Agency or to the Bidder with the highest point total. Rather, a contract will be awarded to the Bidder that offers the greatest benefit to the Agency.

4.2 Evaluation Committee.

The Agency intends to conduct a comprehensive, fair, and impartial evaluation of Bid Proposals received in response to this RFP. In making this determination, the Agency will be represented by an evaluation committee.

4.3 Proposal Scoring and Evaluation Criteria.

The evaluation committee will use the method described in this section to assist with initially determining the relative merits of each Bid Proposal.

Scoring Guide.

Points will be assigned to each evaluation component as follows, unless otherwise designated:

4	Bidder has agreed to comply with the requirements and provided a clear and compelling description of how each requirement would be met, with relevant supporting materials. Bidder’s proposed approach frequently goes above and beyond the minimum requirements and indicates superior ability to serve the needs of the Agency.
3	Bidder has agreed to comply with the requirements and provided a good and complete description of how the requirements would be met. Response clearly demonstrates a high degree of ability to serve the needs of the Agency.
2	Bidder has agreed to comply with the requirements and provided an adequate description of how the requirements would be met. Response indicates adequate ability to serve the needs of the Agency.
1	Bidder has agreed to comply with the requirements and provided some details on how the requirements would be met. Response does not clearly indicate if all the needs of the Agency will be met.
0	Bidder has not addressed any of the requirements or has provided a response that is limited in scope, vague, or incomplete. Response did not provide a description of how the Agency’s needs would be met.

Technical Proposal Components.

When Bid Proposals are evaluated, the total points for each component are comprised of the component’s assigned weight multiplied by the score the Bid Proposal earns. Points for all components will be added together. The evaluation components, including maximum points that may be awarded, are as follows:

Scoring of Cost Proposal Pricing.

Cost Proposal pricing will be scored based on a ratio of the lowest Cost Proposal versus the cost of each higher priced Bid Proposal. Under this formula, the lowest Cost Proposal receives all of the points assigned to pricing. A Cost Proposal twice as expensive as the lowest Cost Proposal would earn half of the available points. The formula is:

Weighted Cost Score = (price of lowest Cost Proposal/price of each higher priced Cost Proposal) X (points assigned to pricing)

Total Points Assigned to Pricing: 3,000.

Total Points Possible for Technical and Cost Proposals: 10,000

4.4 Recommendation of the Evaluation Committee.

The evaluation committee shall present a final ranking and recommendation(s) to the Division Administrator: Adult, Children and Family Services for consideration. In making this recommendation, the committee is not bound by any scores or scoring system used to assist with initially determining the relative merits of each Bid Proposal. This recommendation may include, but is not limited to, the name of one or more Bidders recommended for selection or a recommendation that no Bidder be selected. The Division Administrator: Adult, Children and Family Services shall consider the committee’s recommendation when making the final decision, but is not bound by the recommendation.

The Contractor shall be solely responsible for paying all costs, expenses, and charges it incurs in connection with its performance under this Contract.

1.5 Data and Security. If this Contract involves Confidential Information, the following terms apply:

For purposes of this section, “passed” means no unresolved high or critical findings.

1.5.2 Vendor Security Questionnaire. If not previously provided to the Agency through a procurement process specifically related to this Contract, the Contractor shall provide a fully completed copy of the Agency’s Vendor Security Questionnaire (VSQ).

1.5.3 Cloud Services. If using cloud services to store Agency Information, the Contractor shall comply with either of the following:

- Provide written designation of FedRAMP authorization with impact level moderate prior to implementation of the system, or
- Provide certification of compliance with a minimum of one of the following security frameworks: HITRUST version 9, SOC 2, COBIT 5, CSA STAR Level 2 or greater or PCI-DSS version 3.2 prior to implementation of the system and again when the certification(s) expire.

1.5.4 Addressing Concerns. The Contractor shall timely resolve any outstanding concerns identified by the Agency regarding the Contractor’s submissions required in this section.
