 - a. B. Weekend work shall be allowed but will need to be coordinated with the facility with 48 hrs advance notice.
 - b. C. Area B, D, and F are restricted to work hours of 8:00 AM to 4:00 PM Monday through Friday. No work shall be allowed in these areas on Saturday or Sunday.

 - 2. Unit of Measurement: Per 100 lineal feet of sealant replacement (ADD).
 - 3. See specification section 01 2200 for additional information.
 - 4. Unit prices include all necessary material, plus cost for delivery, installation, insurance, overhead, and profit.
 - 5. Owner reserves the right to reject Contractor's measurements of work in place that involves use of established unit prices and to have this work measured, at the Owner's expense, by an independent surveyor acceptable to the Contractor.
- Unit Price #01B Sealant (DEDUCT): Trade Contractor shall include all of the following, but not limited to, as part of the contract:
 - 1. Description: Deduct the removal of existing backer rod and sealant. Deduct the furnish and install of new backer rod and sealant as noted in the Contract Documents.
 - 2. Unit of Measurement: Per 100 lineal feet of sealant replacement.
 - 3. See specification section 01 2200 for additional information.
 - 4. Unit prices include all necessary material, plus cost for delivery, installation, insurance, overhead, and profit.
 - 5. Owner reserves the right to reject Contractor's measurements of work in place that involves use of established unit prices and to have this work measured, at the Owner's expense, by an independent surveyor acceptable to the Contractor.

- A. Can trailers or storage containers be stored in the immediate work area? *A*> *Enclosed* and locked trailers or storage containers will be allowed to be stored in the immediate work area. Boom lifts and equipment will need to be returned to the parking lot area by the old water tower (NE of Area L) at the end of the work day. All materials shall be stored in enclosed trailers or storage containers.
- B. There are quite a few windows in area B that were replaced about nine to ten years ago during a window replacement project. It looks like 1st and 2nd floor in some of that area. Can you clarify if these windows will need new sealant as noted on general note #4 of the drawings? A> Yes all windows are included. We also have them in the schedule sheet A09.01. Unit Price 01B could be used to adjust the quantity of window sealant, if we feel that some locations can be postponed to a future phase.
- C. *The* question came up yesterday on whether the white panels above the windows are included in general note #4 on the drawings. *A*> *Interpretation of General Elevation*

Note 4: Sealant is to be replaced at the perimeter of the opening, or masonry opening. The top of the white panel is located within the masonry opening, so the sealant around panels shall be replaced. It is still considered a window opening, it just has a panel installed instead of a window sash.
