When units are shipped assembled, units shall be shipped in crates that common carrier trailers can accommodate. Units can be shipped in crates, depending on carrier, up to 15 feet long. Please review your food guard lengths on shop drawings. If your jobsite facility cannot receive and/or accommodate these size crates because of elevators or small openings, please contact us so that we may review your food guards for more breaks in the units. When units include any electrical items(i.e., lights, warmers), breaking the foodguards into smaller sections will require additional re-assembly and wire-chase on-site by others. In addition, units that are not straight runs(angled layouts), require breaks at the corners for separate crating. These breaks also can require additional assembly and wire-chase on-site by others. In these cases, BSI LLC will not accept any backcharges or deductions for additional time and labor.
