**Please amend the subject RFP to include answers to the following timely received questions:**

Q1. What is the current Audio DSP used in the room?

A1. Biamp Tesira Forte Avb

Q2. If the LCD wall was mounted in front of the current screens, but floor supported and covered the current openings so that minimal to no construction is required, would that be an acceptable solution?

A2. No, the existing screens are to be removed and the existing wall will be used for mounting and needed hardware as stated in Addendum Two, A10. Our goal is to maintain the look of the State Emergency Operations Center. Mounts may be placed in the floor if needed for support; minimal external mounts are preferred.

Q3. Is this project a Davis Bacon Act project whereby the Davis Bacon guidelines need to be followed?

A3. Yes.

Q4. Can an additional sites visits be arranged prior to the bid due date? This would be necessary to determine construction subcontracting.

A4. The State will allow one additional site visit which is open only to Bidders who attended the original mandatory site visit. Attendance is voluntary for the second site visit. Vendor questions will not be addressed at this site visit. The site visit is only being provided to allow site access. The Issuing Officer will be present at all times. Bidders may attend the site visit at any time during the designated hours below and may bring additional staff or sub-contractors to the site visit. The State asks that each Bidder bring no more than three additional staff or sub-contractors to the site visit since the site is located in a restricted access building.
