### Addendum One

**Please amend the subject RFB to include answers to the following timely received questions:**

- Q1. Chassis Specs: Do you require the vehicle to have off road capability to require the 4x4?  
A1. No.
- Q2. Rear Doors: 48" Challenger 1550 Series doors with dead bolt and T style door holdback is specified. Will a Challenger 1520 Door with locking paddle handle be acceptable? Challenger 1520 doors are better constructed door for the application being used.  
A2. Having the option to go with either door is preferred since we do not know the difference between the two.
- Q3. Flooring: Floor is repeated in the specifications. One section specs gray Coinlock covering on the floor and the other section specs "Rhino Line/Scorpion Type" non-skid black spray on. What flooring is preferred?  
A3. Rhino Line/Scorpion Type is preferred.
- Q4. Lighting: 2-Reverse lights mounted on either side of license plate frame switched at CS rear bench are specified.  
a) Are these lights independent from the Stop, Tail, Turn and backup lights?  
b) Will these lights need to work with the backup lights from the chassis?  
A4. a) Yes  
b) No
- Q5. Insulation Package: Wall insulation package with carpet covered lining is specified. The body construction is FRP (fiberglass reinforced panels)/ no wall cavity. Do you want the inside of the walls covered with Carpet?  
A5. No. We do not want the inside of the walls covered with carpet.

- Q6. Tow Hitch: Red rope lights mounted under rear seats is specified.  
Under Seat Lights: LED strip lighting under rear bench seat lids is also specified.

Under seat lighting is called out in two different sections. Are you looking for RED/WHITE lighting under the bench seating?

- A6. The State is deleting the specification "Red rope Lights mounted under rear seats" in the Tow Hitch section of the specifications. The State is seeking "LED Strip lighting under rear bench seat lids" as specified in the Under Seat Lights section of the specifications.

- Q7. Ballistics/Bullet proof for the vehicle:  
What caliber of ballistic and threat level do you require.

- A7. In Section 3.4 – Additional Equipment and Accessories of the RFB Criteria document, the State is seeking the following threat level:

Ballistic Driver and Passenger door glass	Threat level 4. Capable of stopping Rifle up to 7.62 cal. and lower
Ballistic Side Doors in Box	Threat level 4. Capable of stopping Rifle up to 7.62 cal. and lower
Ballistic Rear Doors in Box	Threat level 4. Capable of stopping Rifle up to 7.62 cal. and lower
Ballistic Windows in Rear Box	Threat level 4. Capable of stopping Rifle up to 7.62 cal. and lower
