Description of Bid Opportunity (Scope of Work):

1. Contractor will be expected to:
  - a. Create an Early Mathematics Alternate Screener aligned to Iowa's Essential Elements for grades K-6
  - b. Create an Early Mathematics Alternate Progress Monitoring Tool aligned to Iowa's Essential Elements for grades K-6
  - c. Conduct content reliability and validity studies on deliverables a and b
  - d. Create professional learning for Iowa educators to implement deliverables a and b
  - e. Create and conduct a data collection for the Spring 2026 pilot of deliverables a and b

Proposals will be evaluated and a recommendation will be made using the following criteria, which are listed in no particular order:

Review Criteria:

1. Alignment to Iowa Mathematics Essential Elements
2. Meets all grades in the grade band k-6
3. Professional learning focused on emergent and conventional mathematical concepts
4. Meets screening requirement of three times per year, with benchmarks and targets identified
5. Progress monitoring tool
6. Content validity and interrater reliability studies
7. Data collection for Spring 2026 Pilot

Proposals submitted should include the Vendor's Cost Proposal and sufficient information regarding the Vendor's ability to perform the services as identified in the Scope of Work. The Vendor should also include references with its Proposal.

From the issue date of this Informal Bid until announcement of the successful bidder, Vendors may contact **ONLY** the Issuing Officer.
