Additional fee charged per container when the total container count is 16 or more on a regularly scheduled service date. The \$5 fee is only charged for containers 16 and over.

Also applies if a current or new service location requests 16 or more containers more than once a week.

Commodity lines one, two, five and six still apply respectively for each service call for the containers collected on this line.

Example: If 18 containers are collected for a scheduled service, the agency will be invoiced \$20 for the service call plus \$15 for the three extra bins.
