CoderZ is very excited about the opportunity to work with schools across Iowa, building on the small but growing community of educators across the state that have utilized the CoderZ platform. I'm a sixth, seventh, and eighth grade engineering and architecture teacher at a STEAM Magnet in the Los Angeles Unified School District. I've been using CoderZ for the entirety of the 2019-20 school year as part of my Automation and Robotics curriculum as well as with my after-school robotics teams. I have also had students work with CoderZ at SkillsUSA national competitions in previous years.
