**Amendment No. 1
To Contract # 5111-16
Connected Nation, Inc.**

This amendment No. 1 (“**Amendment**”) to Contract #5111-16 dated October 1, 2015, (the “**Contract**” or “**Agreement**”) is made and entered into as of the date of last signature below (“**Effective Date**”), and shall apply retroactively beginning as of August 1, 2017, by and between Connected Nation, Inc. (“**Vendor**” or “**Contractor**”), and the State of Iowa, acting by and through the Iowa Office of the Chief information Officer (“**OCIO**” or “**Office**”). Vendor and the Office may be referred to individually as a “**Party**” and together as the “**Parties.**” Any defined terms used in this Amendment shall have the same meaning as given it in the Agreement, unless otherwise stated herein.

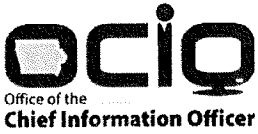
NOW, THEREFORE, the Parties hereby agree to modify and amend the Agreement, as may have been previously modified and amended, as follows:

Item 1. Amendment to Section 1.5.1 (Pricing) is deleted in its entirety and replaced with the following:

The Contractor will be compensated in accordance with the hourly rate (\$125 per hour) that Contractor provided in their RFP Attachment #3 Cost Proposal. Notwithstanding the foregoing, the Contractor may agree to provide Deliverables to the State of Iowa Department of Public Safety at rates less than the hourly rate of (\$125 per hour), as memorialized in the applicable Statement of Work and/or Delivery Order entered into under this contract for work performed on its FirstNet Project.

The Contractor shall submit an invoice for Deliverables rendered in accordance with this Contract. The invoice shall comply with all applicable rules concerning payment of such claims. The Agency shall verify the Contractor's performance of the Deliverables outlined in the invoice before making payment. The Agency shall pay all approved invoices in arrears and in conformance with Iowa Code 8A.514. The Agency may pay in less than sixty (60) days, but an election to pay in less than sixty (60) days shall not act as an implied waiver of Iowa Code§ 8A.514.

Unless otherwise agreed in writing by the parties, the Contractor shall not be entitled to receive any other payment or compensation from the State for any Deliverables provided by or on behalf of the Contractor under this Contract. The Contractor shall be solely responsible for paying all costs, expenses and charges it incurs in connection with its performance under this Contract.


