Questions

Q1: Does this contract replace of several existing contracts for public safety items?

A1: No, the State of Iowa is only replacing a single contract, MA 5102E for Police Supplies, that is set to expire on August 31, 2021. The current contracts of the Department of Public Safety including NASPO will not be affected nor replaced as a result of this solicitation.

Q2: In lieu of an online catalog, do bidders have the option of having agencies order from the PDF catalog by email, phone, postal mail?

A2: Yes, this is fine. Please make note of that on your bid.

Q3: Will the agency consider extending the bid close by at least one week?

A3: No, the bids are still due August 4, 2021 at 2 PM.

Q4: When will the contract start and how many renewals are possible with the contract?

A4: The contract is slated to start by August 30, 2021 and will have an initial year term and up to five renewals at the discretion of the State. The total term of the contract is a maximum of six years.

Q5: What is meant by outerwear?

A5: Outerwear can be coats, duty parkas, spring and high viz jackets, weather resistant rain parkas, jumpsuits, hoodies, jackets, job shirts, 1/4 zip pull overs, sweaters, and vest type wear.

RFB Clarifications

Section 3 Specifications- Section 3.1.1 (page nine)

The Supply Category of Gear will no longer have body armor and ballistics and duty uniforms as part of its description. These two exclusions will not be part of the resulting contract.
