### **Amendment No. 1 to Agreement No. 20412**

This Amendment No. 1 ("**Amendment**") to contract number 20412 ("**Agreement**") (leveraging NASPO ValuePoint Master Agreement MA176-01 ("**Master**")), signed May 12, 2020, by and between the State of Iowa, acting by and through the Department of Administrative Services, assigned to the Department on Management on May 29, 2025 and T-Mobile USA, Inc. ("**Vendor**"), is made, entered into, and effective as of the date of last signature below. This Amendment will remain coterminous with the Agreement. The Amendment modifies, to the extent specified below, the terms and conditions of the Agreement:

#### **Section 1: Background.**

The following changes to the agreement are necessary due to the assignment of the State of Iowa Participating Addendum 20412 to the Iowa Department of Management (DOM), the Participating Entity.

#### **Section 2: Amendment to the Agreement.**

**Revision 1:** Section 2 – All references to the State Chief Procurement Official are removed. The Director of the Iowa Department of Management has authority for this Agreement as opposed to the Chief Procurement Officer. Iowa Code ch. 8 (2024).

**Revision 2:** Throughout the Agreement, "Purchase Orders" shall mean "Purchasing Instrument" as defined here: "**Purchasing Instrument**" means an individual transactional document executed hereunder for the purchase of Deliverable(s) pursuant to this Agreement, regardless of form, and which identifies the specific Deliverable(s) to be purchased and any Acceptance Criteria or Specifications related thereto.

**Revision 3:** Section 5 – "The administration fee due to the State of Iowa shall be paid quarterly by Contractor directly to the Participating State, made payable to the "Iowa Department of Administrative Services". Send to: State of Iowa - DAS/Central Procurement, Attention: DAS-CP COO 1305 E. Walnut St. Des Moines, IA 50319" is struck and replaced with:

**Section 3: Ratification and Authorization.** Except as expressly amended and supplemented herein, the Agreement shall remain in full force and effect, and the parties hereby ratify and confirm the terms and conditions thereof. Each party to this Amendment represents and warrants to the other that it has the right, power, and authority to enter into and perform its obligations under this Amendment, and it has taken all requisite actions (corporate, statutory, or otherwise) to approve execution, delivery and performance of this Amendment, and that this Amendment constitutes a legal, valid, and binding obligation.

**Section 4: Execution.** In consideration of the mutual covenants set forth above and for other good and valuable consideration, the receipt, adequacy and legal sufficiency of which are hereby acknowledged, the parties have entered into the above Amendment and have caused their duly authorized representatives to execute this Agreement.
