CONTRACTUAL AGREEMENT FOR CELLULAR VOICE, DATA AND RELATED PRODUCTS BETWEEN U.S. CELLULAR AND IOWA STATE UNIVERSITY

This Contractual Agreement for cellular voice, data and related products (hereafter referred to as "Agreement" or "Contract") is made and entered into July 1, 2022 ("Effective Date"), by and between lowa State University on behalf of the Iowa Department of Administrative Services and Board of Regents Universities (State University of Iowa, Iowa State University and University of Northern Iowa) (hereafter "the Agencies") and U.S. Cellular (hereafter "Contractor") (each a "party" and together the "parties").

IN CONSIDERATION OF the mutual promises and covenants contained herein, the Agencies and Contractor agree that this Agreement forms a binding contract.

SECTION I - GENERAL INFORMATION

- 1.1 <u>Contract Description</u> This contract is for cellular phones, tablets and related services as described in RFQ-1000517.

1.3 <u>Term of the Agreement</u> This Contract will commence on July 1, 2022 and will continue until June 30, 2025. Optional one-year renewal terms are allowed upon mutual written agreement.

SECTION II – CONTRACT SPECIFICATIONS

- 2.1 <u>Pricing Pricing will</u> be based on U.S. Cellular's response to RFQ-1000517 and is attached as Exhibit 1. U.S. Cellular will continue to offer new rate plans to the Agencies as such plans become available. New plans may be incorporated into the contract after review and acceptance by the Agencies. The Agencies expect any new plan that is advertised on national media to be made available to the Agencies within 90 days, when applicable.
- 2.2 <u>Subsidized Equipment</u> All subsidized equipment per line limited to 3 devices over the 60 month contract period.
- 2.3 Equipment Insurance U.S. Cellular offers the Agencies the option to purchase a third party's Device Protection+ plans for certain mobile devices, as more fully described on U.S. Cellular's Web site, at_ www.uscellular.com/phone-tablet-protection. Pricing and deductibles vary by device and are subject to change. Availability is also subject to change. If such coverage is desired, then a Device must be enrolled in a Device Protection+ Plan within 30 days of device activation. The Agencies and their authorized users may enroll in Device Protection+ at point-of-sale or by dialing 611 from their U.S. Cellular device.
- 2.4 <u>Fees</u> If line cancels within 6 months or less from receiving subsidized equipment an Early Termination Fee will be charged. There will be no Activation Charge fees for the Agencies accounts. Early Termination Fees are listed below:
 - \$350.00
 - Smartphones & tablets
 - USCC subsidized IoT (M2M) routers and gateways
 - \$150.00
 - Feature phones
 - Wireless modems & hot spots
 - Vehicle Monitoring (Delphi)
 - COE/BYOD device activated on a new line
 - Home phones & routers (with and without voice)
- 2.5 <u>Switcher Credit</u> A one-time switcher credit of \$100.00 will be offered for new smartphone activations on lines with minimum monthly charge of \$43.00.
- 2.6 Demo Devices Demonstration devices are available to Agencies upon request.
- 2.7 <u>Tethering</u> Tethering services are included on all current plans at no additional charge.
- 2.8 <u>Reporting Contractor must provide the Agencies with quarterly usage reports detailing all lines of service provided or any available additional special reports as requested.</u>

2.9 <u>Online Portal</u> Contractor has an online self-care portal and will provide access to the Agencies upon request. Contractor will prioritize the Agencies' accounts in on-boarding to this service at that time.

- 2.10 <u>Service Coverage Improvements</u> Contractor work together with the Agencies to address problems in particular locations, as the Agencies identify perceived problems to Contractor. Contractor will cooperate to develop reasonable solutions at manageable costs. Costs will be negotiated between the parties on a case-by-case basis, and Contractor will be mindful both of the Agencies' priorities and budgetary constraints.
- 2.11 <u>Payment</u> Acceptable forms of payment must include credit card payment in the form of institutional procurement card. Payment terms must be Net 60 pursuant to Iowa Code.
- 2.12 Partner Employee Discount Program (PED) All of the Agencies' employees will receive a \$5 discount off qualifying personal postpaid rate plans, provided that such participants comply with all of the U.S. Cellular policies and guidelines in effect at the time when the end user enrolls in PED. This discount may not be combined with other promotional offers. Discount is valid for 24 months. The discount will automatically drop off at the end of the 24th month. As expiration approaches, customers will be sent reminders to revalidate 90, 60, and 30 days prior to expiration. In order to gain access to the discounts, State employees may visit uscellular.com/partner. Upon entering their name and state e-mail address, they will receive an e-mail with their eligible discount. They will then be prompted to continue with the process to have their discount eligibility verified. If all eligibility requirements are met, the discount will be applied to the end user's account within the next two bill cycles.

SECTION III – TERMS AND CONDITIONS

- 3.1 Assignment This Contract (including any future amendments incorporated into the Contract) may not be assigned, transferred, sold, or subcontracted by Contractor without the prior written consent of the Agencies. Should Contractor be purchased (in whole or in part) by another organization or should Contractor wish to assign, transfer, or subcontract the Contract to another Contractor, the Agencies shall have the right to terminate the Contract upon reasonable written notification, without penalty to the Agencies. In the event of a merger, consolidation, acquisition, reorganization or sale of all or substantially all of Contractor's assets, Contractor will notify the Agencies at the earliest opportunity. Should Contractor be purchased (in whole or in part) by another organization or should Contractor wish to assign or transfer the Contract due to a merger, consolidation, acquisition, reorganization or sale of all or substantially all of Contractor's assets, the Agencies shall have the right to terminate the Contract upon reasonable written notification, without penalty to the Agencies.
- 3.2 <u>Amendments to the Contract</u> This Contract shall not be changed, modified, altered, or amended in any respect without the mutual consent of the parties hereto, which consent shall be evidenced by a written amendment to the Contract executed by both parties.
- 3.3 <u>Indemnification</u> The Contractor shall indemnify and hold harmless the Agencies and their agents and employees from and against all claims, damages, losses and expenses, including but not limited to attorneys' fees, arising out of or resulting from (A) the material non-performance, non-compliance or breach with terms and obligations of this Contract or (B) relating to personal injury, death or damage to tangible personal property that is alleged to have resulted, in whole or in part, form any negligent or wrongful act or omission of Contractor or its subcontractor, directors, officers, employees and authorized agents.
 - The Contractor's indemnification obligation shall not be limited in any way by any definition or boundary on the amount or type of damages, compensation or benefits payable by or for the Contractor or any subcontractor under workers' compensation, disability benefits or other employee benefit acts. Notwithstanding the preceding sentence, to the extent permitted by lowa law, Contractor may not be liable for any incidental, indirect or consequential damages (including without limitation, lost profits or lost business opportunities), punitive or exemplary damages or attorneys' fees, whether or not the other party was aware or should have been aware of the possibility of such damages.
- 3.4 <u>Immunity from Liability</u> Every person who is party to this agreement is hereby notified and agrees that the Agencies, successors, and assigns are immune from liability and suit for or from Contractor's activities.
 - Contractor's maximum liability for any loss or damage arising out of a wireless Service outage or wireless product failure is limited to a prorated portion of the applicable monthly recurring charge based on the time period wireless Services are not available.
- 3.5 Severability of the Contract In the event any one or more of the provisions contained in this Contract shall for any reason be held to be invalid, illegal or unenforceable in any respect, such invalidity, illegality, or unenforceability shall not affect any other provision of this Contract, but this Contract shall be construed as if such invalid or unenforceable provision had never been contained. Further, in the event that any provision of this Contract shall be held to be unenforceable by virtue of its scope, but may be made enforceable by a limitation thereof, such provision shall be deemed to be amended to the minimum extent necessary to render it enforceable under the laws of the jurisdiction in which enforcement is sought.

- 3.6 <u>Termination Non-appropriation of Funds</u> Notwithstanding any other provisions of this Contract, if funds anticipated for the continued fulfillment of this Contract are at any time not forthcoming or insufficient, either through the failure of the lowa Legislature or the Federal government to provide funds or alteration of the program under which funds were provided, then the Agencies shall have the right to terminate the Contract without penalty by giving written notice documenting lack of funding.
- 3.7 <u>Laws</u> Terms and provisions of this Contract shall be construed in accordance with the laws of the State of Iowa, and any and all litigation or actions commenced in connection with this Contract resulting shall be instituted in the appropriate court(s) of the State of Iowa.
- 3.8 <u>Use of Name or Intellectual Property</u> Contractor shall not use the name or any intellectual property identifying the Agencies, including, but not limited to, any of the Agencies trademarks or logos, or the name of any employees of the Agencies in any publicity, advertisement or endorsement or as a business reference, without the expressed prior written consent of the Agencies.
- 3.9 <u>Force Majeure</u> Subsequent to acceptance by the Agencies, neither party shall be liable for damages due to: lightning, fire, explosion, pest damage, strikes or labor disputes of third parties, floods, acts of God, war, civil disturbances, acts of civil or military authorities or the public enemy, inability to secure raw materials, fuel or energy shortages, acts or omissions of communications carriers, unauthorized use of the products, or other causes beyond the party's reasonable control whether or not similar to the foregoing.
- 3.10 Right to Setoff The Agencies may withhold from payment to Contractor, in such an amount or amounts as may be necessary to cover:

Payments in the event Contractor has failed to perform any of its duties or obligations as set forth in this Contract; or any services/ equipment furnished under this Contract has failed to meet or conform to applicable specifications and the Contractor has not remedied or cured such deficiency within a 30 day cure period after notice. In the event that Contractor owes the Agencies any sum under the Contract, any other contract or agreement, pursuant to a judgment, or any law, the Agencies may, in their sole discretion, set off any such sum invoiced by, or owed to Contractor under this Contract or any sum or amount owed by the Agencies to Contractor, unless otherwise required by law.

- 3.11 <u>Failure to Enforce</u> The Agencies shall not be required to enforce any right or remedy available under the Contract; however, if Agencies elect to waive a right or remedy under this Contract, the Agencies shall not be precluded from asserting said right or remedy thereafter.
- 3.12 Access to Contractor Records/Audits Contractor shall retain all records and documents and shall provide unlimited access, at all reasonable times and upon reasonable notice, to all accounting records and supporting documentation relating to the goods and services furnished during the term of this Contract and for a period of seven (7) years thereafter, unless required to retain for a longer period by state or federal statute. The Agencies reserves the right to audit such records and employ the Auditor of the State of Iowa or any other auditor the Agencies deem appropriate to perform an audit of Contractor records. Should such audit disclose incorrect billings in excess of 5% or other financial improprieties, the Agencies reserve the right to charge Contractor for the cost of the audit and pursue appropriate reimbursement.
- 3.13 <u>Code of Fair Practice</u> Contractor shall not discriminate against any employee or applicant for employment because of race, creed, color, religion, national origin, age, sex, pregnancy, disability, geneticinformation,

status as a U.S. veteran, service in the U.S. military, sexual orientation, gender identity, associational preferences, or any other classification that deprives the person of consideration as an individual. Contractor shall take affirmative action to ensure that applicants are employed and that the employees are treated during employment without regard to their race, creed, color, religion, national origin, age, sex, pregnancy, disability, genetic information, status as a U.S. veteran, service in the military, sexual orientation, gender identity, associational preferences, or any other classification that deprives the person of consideration as an individual except where it relates to a bona fide occupational qualification. In performance of this Contract, Contractor shall comply with provisions stipulated in Executive Order 11246, or amended by executive order 11375.

In the event of Contractor's noncompliance with the above nondiscrimination clause of this C ontract or with any of the aforesaid or related regulations, this Contract may be canceled, terminated, or suspended in whole in part and Contractor may be declared ineligible for further agreements with the Agencies. In addition, the Agencies may take any actions or other sanctions as may be imposed or remedies invoked as provided by the Code of Iowa.

- 3.14 <u>Gratuities</u> The laws of the State of lowa provide that it is a criminal offense to offer, promise or give anything of value or benefit to a state employee with the intent to influence that employee's acts, opinion, judgment, or exercise of discretion with respect to that employee's duties. Evidence of violation of this statute will be turned over to the proper authority.
- 3.15 <u>Termination</u> If Contractor is adjudged bankrupt or makes a general assignment for the benefit of creditors or if a receiver is appointed on account of Contractor's insolvency, then the Agencies may, after giving Contractor written notice, terminate this Contract, without penalty to the Agencies.

If the Contractor has failed to deliver goods or services, has delivered non-conforming goods or services or is otherwise in material breach of this Contract, the Agencies shall provide a 30 calendar day right to cure notice ("Cure Notice"). The Agencies may, within their sole discretion, accept or reject any or all proposed cure actions. If after such 30 calendar day notice the Contractor continues to be in default, Agencies may, within their sole discretion, terminate the Contract without any further obligation or penalty and procure substitute services from another source and charge the difference between the contracted price and the market price to the Contractor.

With the mutual agreement of both parties, the Contract may be terminated on an agreed date prior to the end of the contract period without penalty to either party.

The Agencies may terminate this Contract without penalty for any reason by giving a 30 calendar day notice.

- 3.16 <u>Taxes</u> The Agencies are exempt from Federal Excise Taxes, and no payment will be made for any taxes levied on Contractor's employees' wages. The Agencies are exempt from State and Local Sales and Use Taxes on the services. Tax Exemption Certificates will be furnished upon request.
 - Contractor certifies it is either (a) registered with the Iowa Department of Revenue, collects, and remits Iowa sales and use taxes as required by the Code of Iowa Chapter 423; or
 - (b) not a "retailer" or a "retailer maintaining a place of business in this state" as those terms are defined in the Code of Iowa §§ 423.1(47) & (48). The Contractor also acknowledges that the Agencies may declare the Contract void if the above certification is false. The Contractor also understands that fraudulent

certification may result in the Agencies or its representative filing for damages for breach of contract.

- 3.17 Software Accessibility Software solutions, when provided to the Agencies as a part of this Contract, shall be compliant with Federal statute Section 508 standards and W3C.org Web Content Accessibility Guidelines (WCAG 2.1 Level AA) for accessibility for persons with disabilities for the minimum level of accessibility. Please review the links provided for specifics related to these referred to standards and guidelines. WCAG guidelines_www.w3.org/TR/WCAG20/ and Section 508 www.section508.gov/. The Agencies reserve the right to request that the Contractor provide audit and/or test results that document the software's compliance and the testing methodology utilized.
- 3.18 <u>Subcontractors</u> Contractor shall be responsible for the acts and performance of any subcontractor that Contractor may engage to fulfill any of its obligations set forth in the Contract. Contractor shall be responsible for payment to all subcontractors and Contractors.
 - (a) All services provided for Contractor by a subcontractor shall be pursuant to an appropriate agreement between Contractor and subcontractor. The Contract shall contain provisions that (1) preserve and protect the rights of the Agencies and (2) require services be performed in accordance with the requirements of the Contract.
 - (b) Contractor is specifically advised that any person, firm, or other party to whom it is proposed to award a subcontract under this Contract must be acceptable to the Agencies. Any subcontractor(s) must have been identified in the Contractor's proposal in response to this RFP or be approved in writing by the Agencies prior to the subcontractor(s) starting work relating to the Contract.
- 3.19 <u>Targeted Small Business</u> The Agencies are committed to the development of Targeted Small Businesses, a State of lowa program. If subcontracting is necessary, the Contractor will make every effort to use Targeted Small Businesses in the performance of this Contract. A report will be required at the completion of the Contract indicating the extent of Targeted Small Businesses participation.
- 3.20 <u>Contractor's Responsibility</u> Contractor shall obtain all necessary permits, licenses and other government approvals necessary to perform its obligations pursuant to this Contract, and comply with all applicable laws, ordinances, rules, regulations, and lawful orders of any government authority.
- 3.21 Responsibility for Those Performing the Work.
 - (a) Contractor shall be responsible for the acts and omissions of all Contractor's employees and all subcontractors, their agents and employees, and all other persons under contract with Contractor, while performing the duties and responsibilities associated with this Contract.
 - (b) Contractor shall not employ any unfit person or anyone not skilled in the task assigned.
 - (c) Incompetent or incorrigible employees shall be dismissed from the project by Contractor, when so determined a nd r e q ue s t e d by the Agencies. Dismissed individuals shall be prohibited from being employed or utilized by Contractor as part of the services Contractor provides to The Agencies without

the written consent of the Agencies.

3.22 Insurance

Requirements: The Contractor, and any subcontractor, shall maintain in full force and effect, with insurance companies licensed by the State of Iowa, at the Contractor's expense, insurance covering its work during the entire term of this Contract and any extensions or renewals. The Contractor's insurance shall, among other things, be occurrence based and shall insure against any loss or damage resulting from or related to the Contractor's performance of this Contract regardless of the date the claim is filed or expiration of the policy. Policy shall name the Agencies as additional insureds with respect to all operations and work hereunder and shall provide that such insurance applies separately to each insured against whom claim is made or suit is brought. Additional insured form CG 2026 or equivalent are required and must be attached to the certificate.

Types and Amounts of Insurance Required: Unless otherwise requested by the Agencies in writing, the Contractor shall cause to be issued insurance coverage's insuring the Contractor and/or subcontractors against all general liabilities, product liability, personal injury, property damage, and (where applicable) professional liability in the amount of One Million Dollars (\$1,000,000) on the Contract Declarations and Execution page for each occurrence. In addition, the Contractor shall ensure it has any necessary workers' compensation and employer liability insurance as required by Iowa law. Contractor shall maintain Comprehensive Commercial General Liability Insurance and Automobile Liability Insurance in the amount not less than Two Million Dollars (\$2,000,000) for injuries, including accidental death, to any one person and subject to the same limit for each person, and in an amount not less than One Million Dollars (\$1,000,000) on account of any one occurrence. Property damage liability insurance shall be in the amount not less than One Million Dollars (\$1,000,000).

Certificates of Coverage: All insurance policies required by this Contract shall remain in full force and effect during the entire term of this Contract and any extensions or renewals thereof and shall not be canceled or amended except with the advance written approval of the Agencies. The Contractor shall submit certificates of the insurance, which indicate coverage and notice provisions as required by this Contract, to the Agencies upon execution of this Contract. The certificates shall be subject to approval by the Agencies. The insurer shall name the Agencies in the certificate that no cancellation of the insurance will be made without at least thirty (30) days' prior written notice to the Agencies. Approval of the insurance certificates by the Agencies shall not relieve the Contractor of any obligation under this Contract.

Waiver of Subrogation Rights. The Contractor shall obtain a waiver of any subrogation rights that any of its insurance carriers might have against the Agencies. The waiver of subrogation rights shall be indicated on the certificates of insurance coverage supplied to the Agencies.

3.23 Export Control Contractor shall comply with all U.S. export control laws and regulations, including but not limited to the International Traffic in Arms Regulations (ITAR), 22 CFR Parts 120 through 130, and the Export Administration Regulations (EAR), 15 CFR Parts 730 through 774, in the performance of this Contract. In the absence of available license exemptions/exceptions, Contractor shall be responsible for obtaining the appropriate licenses or other authorizations, if required, for exports of hardware, technical data, and software, or for the provision of technical assistance. Contractor shall be responsible for all regulatory record keeping requirements associated with the use of licenses and license exemptions/exceptions.

Prior to disclosing or transferring to the Agencies any hardware, technical data, software or product utilizing any hardware, technical data or software which is subject to export controls under federal law, Contractor shall notify the Agencies in writing of the nature and extent of the export control. The Agencies shall have the right to decline any such technical data or product utilizing such data. In the event Contractor sends any such technical data or product that is subject to export control, without notice of the applicability of such export control, the Agencies have the right to immediately terminate this Contract.

- 3.24 <u>Packaging, Transportation, and Handling</u> All packaging, transportation and handling of hazardous materials shall be in accordance with applicable federal and state regulations including, but not limited to, the Material Safety Data Sheet provision of O.S.H.A. Hazard Communication Standard 29 CFR 1910.1200, and Iowa Administrative Code.
- 3.25 <u>Termination for Convenience of the Federal Government</u> Notwithstanding any other provisions of this Contract, if this Contract is federally funded then the Agencies shall have the right to terminate this Contract at the direction of the Federal Government for convenience with 30 calendar days written notice. If allowed by the Federal Government, the Agencies will pay the Contractor for work performed up to the point notice was received by the Contractor.
- 3.26 <u>FAR Employment Eligibility Verification</u> This contract may involve funding subject to applicable Federal Acquisitions Regulations (FAR) Employment Eligibility Verification clauses of the prime contract. Contractor shall comply with all terms and conditions of the FAR Employment Eligibility Verification clause (FAR 52.222-54).
- 3.27 <u>Federal Compliance</u>: Contractor shall comply with the provisions set forth below if applicable and shall include them in its subcontracts. These provisions are available in Appendix A to 2 CFR 215 on the following website:

Equal Employment Opportunity -All contracts shall contain a provision requiring compliance with E.O. 11246, "Equal Employment Opportunity" (30 FR 12319, 12935, 3 CFR, 1964-1965 Comp., p. 339), as amended by E.O. 11375, "Amending Executive Order 11246 Relating to Equal Employment Opportunity," and as supplemented by regulations at 41 CFR part 60, "Office of Federal Contract Compliance Programs, Equal Employment Opportunity, Department of Labor."

Copeland "Anti-Kickback" Act (18 U.S.C. 874 and 40 US.C. 276c) -All contracts and subgrants in excess of \$2000 for construction or repair awarded by recipients and subrecipients shall include a provision for compliance with the Copeland "Anti-Kickback" Act (18 U.S.C B74), as supplemented by Department of Labor regulations (29 CFR part 3, "Contractors and Subcontractors on Public Building or Public Work Financed in Whole or in Part by Loans or Grants from the United States"). The Act provides that each contractor or subrecipient shall be prohibited from inducing, by any means, any person employed in the construction, completion, or repair of public work, to give up any part of the compensation to which he Is otherwise entitled. The recipient shall report all suspected or reported violations to the Federal awarding agency.

Davis-Bacon Act, as amended (40 U.S.C. 276a to a-7) -When required by Federal program legislation, all construction contracts awarded by the recipients and subrecipients of more than \$2000 shall include a provision for compliance with the Davis-Bacon Act (40 U.S.C. 276a to a-7) and as supplemented by Department

of Labor regulations (29 CFR part 5, "Labor Standards Provisions Applicable to Contracts Governing Federally Financed and Assisted Construction"). Under this Act, contractors shall be required to pay wages to laborers and mechanics at a rate not less than the minimum wages specified in a wage determination made by the Secretary of Labor. In addition, contractors shall be required to pay wages not less than once a week. The recipient shall place a copy of the current prevailing wage determination issued by the Department of Labor in each solicitation and the award of a contract shall be conditioned upon the acceptance of the wage determination. The recipient shall report all suspected or reported violations to the Federal awarding agency. This does not apply to Federal disaster funding unless otherwise specified by local regulations.

Contract Work Hours and Safety Standards Act (40 U.S.C 327-333) -Where applicable, all contracts awarded by recipients in excess of \$2000 for construction contracts and in excess of \$2500 for other contracts that involve the employment of mechanics or laborers shall include a provision for compliance with sections 102 and 107 of the Contract Work Hours and Safety Standards Act (40 U.S.C. 327-333), as supplemented by Department of Labor regulations (29 CFR part 5). Under section 102 of the Act, each contractor shall be required to compute the wages of every mechanic and laborer on the basis of a standard work week of 40 hours. Work In excess of the standard work week is permissible provided that the worker is compensated at a rate of not less than 1 ½ times the basic rate of pay for all hours worked in excess of 40 hours in the work week. Section 107 of the Act is applicable to construction work and provides that no laborer or mechanic shall be required to work in surroundings or under working conditions which are unsanitary, hazardous or dangerous. These requirements do not apply to the purchases of supplies or materials or articles ordinarily available on the open market, or contracts for transportation or transmission of intelligence.

Rights to Inventions Made Under a Contract or Agreement -Contracts or agreements for the performance of experimental, developmental, or research work shall provide for the rights of the Federal Government and the recipient in any resulting invention in accordance with 37 CFR part 401, "Rights to Inventions Made by Nonprofit Organizations and Small Business Firms Under Government Grants, Contracts and Cooperative Agreements," and any implementing regulations issued by the awarding agency.

Section 503 of the Rehabilitation Act of 1973, as amended (29 U.S.C. 793) - This Contractor and Subcontractor shall abide by the requirements of 41 CFR 60-741.5(a). This regulation prohibits discrimination against qualified individuals on the basis of disability, and requires affirmative action by covered prime contractors and subcontractors to employ and advance in employment qualified individuals with disabilities.
