1. Scope: This Addendum covers the WSCA/NASPO (Tires, Tubes, and Services) lead by the State of Utah for use by state agencies and other entities located in the Participating State authorized by that state's statutes to utilize state contracts.

2. Changes: The following terms and conditions will be added to the Participating Addendum for the Participating State:

- A. The contractor shall provide the state of Iowa with a 1.00% rebate on all sales made within the state of Iowa against this agreement. The rebate is to be paid quarterly to: The Iowa Department of Administrative Services, General Services Enterprise - Purchasing Hoover State Office Building, Level A, 1305 E. Walnut, Des Moines, IA 50319-0105
- B. The Contractor shall provide an electronic detailed quarterly report on all sales made against this agreement within the State of Iowa to the State's primary contract below. The report file format shall be Microsoft Excel compatible format. The report shall include the date of sale, customer name, address, product description, quantity, invoice number, unit and extended invoice prices.
- C. Contractor's stated prices shall be discounted using the discounts and price lists approved and agreed to with WSCA/NASPO under the master price agreement. The stated discounts are considered to be the minimum discounts offered. The Contractor may offer, within written quotes, a higher discount than the approved minimum discount for volume purchases or for other competitive reasons.
