The report shall include the date of sale, customer name, address, product description, quantity, invoice number, unit and extended invoice prices.
 - C. Contractor's stated prices shall be discounted using the discounts and price lists approved and agreed to with WSCA/ NASPO under the master price agreement. The stated discounts are considered to be the minimum discounts offered. The Contractor may offer, within written quotes, a higher discount than the approved minimum discount for volume purchases or for other competitive reasons.
