This project includes around 11,900 cubic yards of earthwork, 1,940 square feet of steel sheet pile, 380 linear feet of tile installation, 402 tons of rock riprap, 54 cubic yards of grout, and 4.6 acres of seeding. The estimated construction cost range for this project is \$200,000 to \$250,000.
