The resulting contract will be available to all State Agencies and political subdivisions.

Now, therefore, the parties herein acknowledge and agree that RFB032005023 Section 1.4 is hereby amended as follows:

1.4 Contract Term The term of the contract will begin upon award and end on 10/31/2022. The Agency shall have the sole option to renew the contract upon the same or more favorable terms and conditions for up to three (3) annual extensions. The resulting contract will be available to all State Agencies and political subdivisions.
