## **Description of Good:**

The Department of Natural Resources (DNR) is seeking to purchase one 16-foot flat bottom aluminum boat and trailer meeting the following specifications. FOB Destination: Decorah Fish Hatchery, 2325 Siewers Spring Road, Decorah, Iowa 52101.

HULL MATERIAL: .100 aluminum, 5052 grade

CONSTRUCTION: Welded HULL DESIGN: Flat Bottom

BOW DESIGN: Flat LENGTH: 16' BOTTOM WIDTH: 52"

TRANSOM HEIGHT: No wood construction, angled bracing (minimum 2 braces), 21" transom height. Suitable

for 25 hp jet outboard. SIDE HEIGHT: 20" to 22"

BOTTOM: Ribbed, not to be smooth.

FRONT DECK: Minimum 40" front washout deck with two large drain holes (1" minimum)

GUNWALES: Extruded aluminum, little if any rise towards the front of the boat (i.e., nose of boat should not

curve up or down)

INTERNAL BRACING: Extruded aluminum ribs under floor SEATS: None- no additional seats or seat bases requested.

STORAGE BOXES: See attached document for storage compartments (20"x20"x17" and 20"x24"x17") on starboard and port side of boat to be positioned immediately in front of rear seat benches. Boxes should mount on floor and be moveable as needed.

FLOORING: Full length, perforated aluminum floor with extra ribs to support floor, minimum of .080 perforated with 5/32'' holes on  $\frac{1}{2}$ '' grid staggered. Area between transom and last rib does not need perforated flooring.

TIE DOWNS: One bow mounted and two on transom of boat



BOW EYE: Must be reinforced so boat and motor can be winched up stream banks where no ramp exists

RUNNING LIGHTS: Must meet Coast Guard requirements. Stern light must be removable post style light. Bow light can be removable or permanently mounted. Bases must be installed with concealed wiring and on/off switch for driver

MOTOR RATING: Minimum 40 HP rating

PAINT: NO paint on hull

BILGE PUMP: Installed, with on/off switch for driver


DRAIN PLUG: Standard drain plug on transom

NOTE: Boat is to be equipped with all necessary parts normally furnished for easy mounting and operation


WARRANTY: Minimum 1 year on parts and labor

TRAILER: Heavy duty "roller" trailer for loading/unloading boat in shallow locations. Should be large enough to support boat plus additional equipment weight (generator +150 lbs, fish hauling tank + 500 lbs, misc nets and boat booms + 150 lbs).
