- Q3. Should the thumbprint reader be integrated into Windows and the active directory?
- A3. The thumbprint reader shall be integrated into Windows but NOT the active directory.
- Q4. Is the Contractor to provide the computer that hosts the door control software?
- A4. Yes, The Contractor shall provide the computer. The computer shall not be tied into the existing network however.

 - a. ADD Avigilon ACM as an approved equal.


