#### **Review of Notice of Intent to Award Decision**

The Agency must receive the written request for reconsideration within five days from the date of this Notice of Intent to Award. The written request may be mailed, emailed, or delivered. It is the bidder's responsibility to assure timely delivery of the request for reconsideration. The request for reconsideration shall clearly and fully identify all issues being contested by reference to the page and section number of the RFP. If a bidder submitted multiple Bid Proposals and requests that the Agency reconsider a decision for more than one Bid Proposal, a separate written request shall be submitted for each. At the Agency's discretion, requests for reconsideration from the same bidder may be reviewed separately or combined into one response. The Agency will expeditiously address the request for reconsideration and issue a decision. The bidder may choose to file an appeal with the Agency within five days of the date of the decision on reconsideration in accordance with 441 Iowa Administration Code 7.41 et seq.

# Iowa Child Abuse Prevention Program (ICAPP) Summary of Award Decision

Iowa Child Abuse Prevention Program released RFP ACFS 21-001 on November 18, 2019. Proposals were due January 15, 2020. A total of 95 proposals were received by the deadline. All 95 proposals passed the mandatory requirements review and moved forward in the process for evaluator/group scoring which occurred from February 17th-25th. The following is a breakdown of Projects received:

## **ICAPP Funding Award Methodology and Decisions by Project Category**

The following award guidelines were considered per the RFP:

- The Agency anticipates approximately \$1,700,000 available to award
- The RFP stated an intention of awarding up to 4 Resilient Communities Demonstration Projects
- Funding for Core services estimated at \$1,250,000 (including SAP, PD, HV)
- Funding designated specifically for Sexual Abuse Prevention is \$231,459
- Funds available for home visitation and parent development estimated to be \$1,000,000-\$1,100,000.

In accordance with Iowa Code Chapter 217.3A, and as stated in the RFP, the Child Abuse Prevention Program Advisory Committee (CAPPAC) makes funding recommendations to the Agency Contract Owner, who makes the final award decisions. Award amounts are based on the following funding methodology, by category, with all amounts rounded to the nearest dollar.

## Home Visitation

Proposals in the Home Visitation category that scored <u>65% and above</u> will be funded at the following levels:

- Proposals scoring 85% or higher are awarded 100% of the requested amount.
- Proposals scoring between 75-84% are awarded 95% of the requested amount.
- Proposals scoring between 65-74% are awarded 90% of the requested amount.
- Projects scoring <u>under 65%</u> are not funded.
- Note: All projects in the Home Visitation category will be funded exclusively with CBCAP funds for reporting purposes.

#### Parent Development

Proposals in the Parent Development category that scored <u>60% and above</u> will be funded at the following levels:

- Projects scoring 75% or higher are awarded 100% of the requested amount.
- Projects scoring between 65-74% are awarded 95% of the requested amount.
- Projects scoring between 60-64% are awarded 90% of the requested amount.
- Projects scoring <u>under 60%</u> are not funded.

## **Resilient Communities Demonstration Projects**

Proposals in the Resilient Communities Demonstration Projects category that scored <u>60% and above</u> will be funded at the following levels:

- Proposals scoring 80% and higher are awarded 100% of the requested amount.
- Proposals scoring between 60%-69% are awarded 95% of the requested amount.\*
- Proposals scoring <u>under 60%</u> are not funded.

\*No proposals scored between 70-79% in this category.

### **Sexual Abuse Prevention**

Proposals in the Sexual Abuse Prevention category that scored <u>over 50%</u> will be funded at the following levels:

- Proposals scoring 80% or higher are awarded 100% of the requested amount.
- Proposals scoring between 70-79% are awarded 95% of the requested amount.
- Proposals scoring between 60-69% are awarded 90% of the requested amount.
- Proposals scoring between 51-59% are awarded 85% of the requested amount.
- Proposals scoring <u>50% or lower</u> are not funded.
