## RFB 20CRDWBJRUSK-100 Badger Creek State Recreation Area Tree & Brush Removal Service Questions & Answers

Question: Can a mulch head mower be used to mulch the smaller trees and brush down into the ground as opposed to cutting off level with the ground?

Answer: Yes, anything under 3" DBH can be mulched or ground to ground level.

**Question:** What is the approved herbicide list that the stumps are to be treated with?

Answer: Glyphosate at the rate of 60%, tordon, or garlon 3A.

Question: How tall and how wide must a pile of trees/brush be before starting another pile?

**Answer:** There are no restriction on height of pile. Trees are to be packed tight and at least 150 feet from Badger Creek property boundary and paved access road. A total of 1-11 piles may be made for the outlined area. If more than 11 piles are needed, prior approval from the DNR is required.

Question: In regards to the old piles, can they be pushed into the ditch or do they need left as is?

**Answer:** The old piles can be pushed into the ditch.

**Question:** Do the trees down in the ditches have to be dragged out?

**Answer:** No, trees can be left in ditches.

**Question:** We are a sole proprietor with no employees, do we need a Workmen's Comp policy? Will any subcontractors will need to meet the requirement?

**Answer:** The successful Bidder is required to meet State of Iowa Law for Workers Compensation and Employer Liability. You should contact your insurance provider or legal provider to determine the appropriate coverages for you. All Subcontractors are required to meet the same requirements as the Contractor.
