General Items:

1. Meeting Minutes: RFP Pre-Proposal Meeting held on 08/01/24 (4 Pages)

Questions and Answers:

- Q1. How many rooms can be worked on at a time and what level of complete does the room need to be before moving to the next room?
 - A1. The GC may have access to an entire building wing at a time. The room will need to be complete except for the installation of the solid surface windowsill and the owner's painting scope.
- Q2. Does the solid surface sill need to extend 1" +/- past the window jamb?
 - A2. No, the solid surface does not need to extend past the window jamb. The solid surface sill may stop in line with the window jamb but the gyp behind the existing sill may need to be patched.
- Q3. What are existing finishes?
 - A3. All existing materials / furniture exc. that may be damaged by performing the GC's scope of work or damage done to areas when getting to the defined area of work.

Example – scratch up a hallway wall when carrying a tool to the area you are performing work.

Q4. Do you have photos that can be shared?

- A4. The GC will need to make a site visit to verify the existing conditions.
- Q5. Can we remove all windows or are they phased?
 - A5. See response to question 1.
- Q6. Will they remove all windows or are they phased?
 - A6. Correct, the owner will remove all window curtains, rods, and brackets.
- Q7. How much temporary covering will be needed? Do they want us to leave temporary covering for owners to use while painting.
 - A7. Provide adequate covering for your scope of work. Depending on the project schedule, the owner may ask you to leave your coverings. For bidding, do not plan on leaving your coverings.
- Q8. How many rooms can be demoed at a time? If drywall would like to do as many as possible when texturing to minimize covering and to match finish in all rooms
 - A8. See response to question 1.
- Q9. How do we quantify or estimate what will be rotten/compromised?
 - A9. Note K on sheet A2.00 means the substrate is not adequate to mount/support the new construction.
- Q10. Will the downturn edge be wider than the window width?
 - A10. See response to question 2.

SECTION - 09 9300 - Staining and Transparent Finish

- A. Section 2.03, paragraph A line 2 to read as follows.
 - i. 2. Stain: Semi-transparent stain for wood, water based with polyurethane.
 - a. Color: to be selected from the manufacturer's standard line.

SECTION - 08 5200 - Wood Windows

- A. Question at Pre-Bid: Does the metal flashing above the window need to be supplied by the window manufacturer? Keynote #4 on Sheet A4.00.
- **B.** Answer: No, this flashing piece can be contractor-supplied break metal but the color needs to match the window frame.
