

1. QUESTIONS/CLARIFICATIONS

- a. Clarifications
 - i. MPCF has asked that the awarded contractor provide their own temporary facilities.

- **Q1.** What are the work hours?
- **A1.** The typical hours of operation are 6:00 am to 4:00 pm. MPCF understands that the weather can cause irregular working hours. If the contractor thinks they will need to perform work outside of these hours, they should get prior approval from MPCF.
- Q2. What color would you like the cast iron ADA Detectable Warning pad?
- **A2.** Please match the existing ADA Detectable Warning pads. See the photo below for reference.
- **Q3.** Would you like the clean out poured in the concrete or boxed out?
- **A3.** Clean out casting to be poured integral to the parking lot pavement and include #4 rebar per Detail 6/B.01.
- **Q4.** Do we know the depth of the utilities around the parking lot?
- **A4.** No.
- **Q5.** Can you provide an engineered estimate for the project?
- **A5.** The 100% engineered bid day total estimate was \$244,610.
- **Q6.** Does the form in section 00 4116.02 Targeted Small Business Information need to be filled out and entered with the bid submission?
- **A6.** No, the TSB form is **not** required to be submitted with your bid. The State of Iowa Department of Administrative Services (DAS) encourages contractors that are using subcontractors to utilize TSB, but it is **not** required.
- Q7. Will this project utilize Davis Bacon Wages.
- A7. This project is exempt from Iowa Sales Tax. Davis Bacon Wages will not apply to this project.
- **Q8.** Would conventional seeding be acceptable in lieu of Hydroseeding?
- A8. Conventional seeding is acceptable, but MPCF would prefer Hydroseeding.
