  - d. Q. Will a core sample be taken and results available for the EPDM gutters? A. DAS will have a core sample of the EPDM gutters taken as well as core samples of the existing roofing. The report will be shared with the successful design firm.
  - e. The RFP and Pre-Proposal Agenda appear to have different requirements for the number of cost estimates. Which is correct? *A. Cost opinions will be required as per the RFP. See section* 1.3.21 in the RFP for clarification.
  - f. Are there any active leaks at any areas where roofing is to be replaced? If so, can those locations be identified? *A. No active leaks are identified at this time.*
  - g. Regarding the adjacent work (asphalt shingles at the mansard roofs), what is the anticipated scope of replacement as replacing and integrating new flashings may damage some of the existing shingles? This may occur at each dormer and along each gutter. A. Currently there are no anticipated replacement of existing asphalt shingles at the mansard roofs. The successful design firm will need to address how new flashings will be installed at all the dormer locations.
