Furnish and install temporary construction, demolition, concrete, masonry, steel, rough carpentry, thermal and moisture protection, **vegetated roof components**, glass and glazing, curtain wall, doors, frames, and hardware, finishes, and fire suppression in accordance with contract documents and below inclusions.

Inclusions

- 1. Demolition as noted in the demolition drawings, except for demolition related to mechanical, plumbing, electrical, and roofing systems.
- 2. Demolition required to install new steel.
- 3. Demolition of roof membrane, roof insulation and roof flashings related to the planters is by the Roofing Bid Package Contractor. Demolition of planter roof drains is by the Mechanical Prime Contractor. All other demolition, including soils, related to the planters is by the General Bid Package.
- 4. Planter work by General Construction Bid Package to include geofoam install and any associated masonry work. Mechanical Bid Package to install or cap drains as indicated on contract documents. Roofing contractor to include all roofing work, including termination at existing areas.
- Provide necessary bracing, shoring and other temporary methods required for demolition activities.
- 6. Furnish and install cast-in-place concrete complete. Includes interior and exterior concrete as indicated in the construction documents or as **damaged by this Bid Package during construction.**
- 7. Furnish and install masonry and granite complete, including cleaning and salvage of existing granite as indicated on the contract documents. Contractor responsible

- for relocation of granite not used at the end of the project to Owner storage at lower level of building.
- 8. Furnish and install all wood blocking, including wood blocking required for other Bid Package Contractors scope.
- 9. Furnish and install air barrier and vapor barrier complete.
- 10. Furnish and install all caulking and sealants at all locations integral with or abutting the finished work of this bid package. Caulking shall be installed as required for water tightness and installed with attention to aesthetics. Include exterior and interior caulking/sealants.

- 17. Provide final cleaning for all construction areas and areas directly adjacent to work indicated on construction documents, including but not limited to, exterior and interior glass and glazing, curtainwall system, and temporarily protected areas.
- 18. Furnish, install, and maintain interior temporary protection per contract documents. Includes, but is not limited to, plastic sheeting, walls, doors, door hardware, insulation, drywall finish and painting of temporary walls, caulking (ceiling/floor/walls) and selective demolition as required for installation. Mechanical Bid Package to furnish, install, and maintain their own temporary protection as needed to remove storms drains and piping.
- 19. Furnish and install temporary doors and hardware as indicated in the construction documents at the Lower Level. Doors to have storeroom function lock (cylinders by Owner) and are to have panic hardware to provide free egress into the "construction-side" of the corridor.
- 20. Furnish, install and maintain weather-tight and insulated exterior temporary walls including, but not limited to, north skylights and SE skylight areas.
- 21. Seal off and protect all work completed at the end of the workday.
- 22. Patch all adjacent finishes to match existing or new conditions after removal of temporary protection, including walls, flooring, and ceilings. Mechanical Bid Package to limit disturbance of existing conditions to the best of their abilities and will be responsible for patching of their temporary protection.
- 23. General Bid Package to include snow removal as it is related to the General Bid Package's scope of work for access, etc. Any roofing snow removal to be by other Bid Packages as it relates to their scope of work.
- 24. Provide temporary fire extinguishers and cabinets as required by OSHA.
- 25. Provide all door hardware material and prep work related to wood and hollow metal doors. Security/electronic hardware install by General Bid Package. Provide coordination with Electrical Bid Package.
- 26. Sprinkler calculations/volumes are to be submitted to the State Fire Marshal ILO City of Des Moines.
- 27. Furnish and install complete curtain wall systems including, but not limited to, aluminum framing members, glazing, aluminum clip angles, sills, trims, gaskets, flashings, doors and hardware.
- 28. Contractor acknowledges that quench marks on glass are an inherent characteristic of all heat-treated glass (reference ASTM C1048 Article 7.4). Contractor to develop process for quality assurance/quality control in

- conjunction with the Architect and the specified/selected manufacturer prior to manufacturing of glass.
- 29. Manufacturer shop drawings shall be provided. Structural analysis/calculations including surrounding conditions, thermal analysis, and air/vapor barrier interface shall be included with shop drawing submittals.
- 30. Provide and pay for field testing as called for in the specifications and drawings.
- 31. Furnish and install all items required to be embedded into adjoining system well in advance of the main installation activities.
- 32. Provide all temporary bracing and shoring necessary to install work in this bid package.
- 33. General Construction Bid Package to provide scaffolding and/or lifts for all Bid Packages to access and complete work at four (4) north skylights. This includes, but is not limited to, coverage of additional insurance requirements and coordinating schedule agreements of when scaffolding and/or lifts will be available.
- 34. Bidder understands that this project requires a breakout of pricing for State of lowa budget purposes and will provide a breakout of their pricing for the following work as indicated on the Bid Form:

- i. North Skylight work, including removal of skylight, wall and curb to match existing structural deck elevation, metal framing, gypsum board, and finish work as indicated in the construction documents. General Bid Package to also include scaffold and/or lift costs as outlined in line 33 in above inclusions.
- ii. SE Skylight work adjacent to Library, including removal of skylight, wall and curb to match existing structural deck elevation, bulkhead removal, slab on grade removal and disposal, planter work, curtain wall work, new soffit work and associated finish, and associated masonry work including stone cleaning as indicated in the construction documents.

This bid package has excluded any work to remove or disconnect the stairwell fan units.
- Provide labeling of all duct, pipes, valves and equipment per plans and specifications
- 11. Furnish all starters and disconnects for equipment provided in this Bid Package, except when specified to be furnished by another contractor.

- Provide independent testing and balancing services in accordance with the contract documents.
- 13. Provide all final connections to site utilities five (5) feet outside the building.
- 14. Provide the start-up of all mechanical systems including testing, adjusting and balancing as required for modified areas.
- 15. Provide all permits, testing and fees required for its scope of work in accordance with state code, local codes and Contract Documents.
- 16. Provide temporary protection of grilles/louvers/vents feeding **from** construction zones. Remove temporary protection at end of project. Coordinate with CM and General Bid Package prior to completing work.

Mechanical Bid Package to furnish, install, maintain, and **demolish** their own temporary protection as needed to safely remove storm drains and piping while protecting surrounding exhibits and finishes.
