**But901622D Nutrient Reduction Wetland Project
Section 22, Township 90 North, Range 16 West
Butler County, Iowa**

Sealed bids will be received by the Iowa Department of Agriculture & Land Stewardship, Division of Soil Conservation and Water Quality (Division), 502 East 9th Street, Des Moines, Iowa, 50319, until 3:00 AM local time, on Tuesday, September 19, 2023 and opened at a public meeting and read aloud on the date last mentioned at 3:15PM. Bids must be submitted on the appropriate bid forms provided and shall include a bid bond in the amount of ten percent (10%). Bidders must also be registered with the Iowa Division of Labor.

In general, the work involves, but is not limited to, selective clearing, excavation, grading, tile and SUDAS inlet structure installations, , and seeding. This project includes around 1,000 cubic yards of earthwork, 1,412 linear feet of RCP tile installation, 3 SUDAS structures, 2,000 linear feet of silt fence, and 2.6 acres of seeding. The estimated construction cost range for this project is \$170,000 to \$210,000.

A pre-bid conference will be held at 9:15 AM, on September 5, 2023 at the Butler USDA Service Center, 310 Allan St, Allison, Iowa, 50602, telephone: 319-267-2756. Attendance at the pre-bid conference by prospective bidders is not mandatory, but is encouraged.

The Plans and Construction Specifications governing the construction of the proposed improvements have been prepared by Jon Rosengren, P.E., Bolton & Menk, and are hereby made a part of this notice by reference and the proposed contract shall be executed in compliance therewith. Bidders who attend and sign-in to the pre-bid conference will be added to the plan holders list. Plans and Construction Specifications can be viewed at the Butler Soil and Water Conservation District. Printed copies of specifications and plans will be provided to the successful bidder.

The successful bidder shall be required to furnish a Performance/Payment Bond in an amount equal to one hundred percent (100%) of the contract price.
