Vendor will be responsible for removal of body from either facility in Coralville or Uofl Hospital & Clinics in Iowa City. Contractor will abide by all rules and reuglations as outlined in the Iowa Administrative code Chapter 100 section 645-100.1-645-100.11(4).

Responsibilities of Vendor to include:

- 1. Transfer of deceased offender from IMCC or UIHC upon notification of IMCC staff.
- 2. Perform Direct Creamation Services
- 3. Ship remains to address as provided by IMCC staff
- 4. File Necessary paperwork with state and local officials.
- 5. Request Death Certificate to be sent to IMCC
- 6. Forward death certificate and invoice showing detailed expenses per agreement
- 7. Read & sign off on outside contractor security rules and guidelines for entrance into IMCC facility.
- 8. Provide IMCC with names, dob & ssn of all vendor employees that will need to come on site for body removals. Vendor is responsible for notifying IMCC of any staffing changes.
- 9. On occasion death of an offender will require an autopsy by the medical examiner which will require additional steps by vendor to transport deceased body.
- 10. All services will be billed to IMCC unless staff notifies vendor that the individual's family will be responsible, in this case vendor may have to work with another funeral home and family of individual will be responsible for those charges.

IMCC is a state of lowa govt agency and exempt from all taxes.
