**Description of Good:**

The DNR is seeking to purchase 2 trail bridge kits similar in specifications to the ones found at this address: <https://rollingbarge.com/trail-bridge-kits> or a State of Iowa approved equivalent. This model is intended to illustrate the general characteristics of the bridge kit needed and not meant to limit competition. All equivalents must provide detailed specifications with their quote. Any deviations to the following specifications should be noted next to the specification listed below by either handwriting or inserting a comment next to the specification. The DNR reserves the right to determine if the deviations are acceptable. Vendors must be authorized manufacturer representatives authorized to extend manufacturer's warranties.


The bridges must have a live load rating of at least 90 pounds per square foot or 9,000 lbs, designed to be assembled on site by our park staff, and not require abutments. Due to the terrain of the locations where these bridges will be installed, we will be unable to get mechanical equipment to the install site, so some pieces will need to be delivered by hand. Because of this, the DNR requests that all bids include the dimensions and weight of each unique piece, and that no 1 piece can be more than 150lbs in its ready to assemble form. Please reach out to the issuing officer to discuss this further, if needed.

Bridge 2: 48'x6'
