The DNR is seeking to purchase two Pro-Drive X40, 40 h.p. E.F.I. Shallow water outboard, Motors must be for a tall transom (20"), Motors must have power tilt/trim, full auto-reverse. or a State of Iowa approved equivalent. The *Pro-Drive X40* is intended to illustrate the general characteristics of *Shallow Water Outboard* needed and not meant to limit competition. All equivalents must provide detailed specifications with their quote.
