Quotes should be submitted no later than **December 14, 2017 at 12:00 PM noon central time**. Any quotes received after this deadline will be rejected and returned to the Contractor. The costs of preparation and delivery of the quote are solely the responsibility of the Contractor. **Email quotes preferred.**

Description of Good:

The Department of Natural Resources (DNR) is seeking to purchase **four (4) new boat hoists meeting the following specifications**. Contractors may quote on one (1) or any combination of up to the four (4) boat hoist.

One (1) 7,000lb minimum load capacity with 26 foot canopy tops with a minimum of 124 inch canopy post
Two (2) 5,000lb minimum load capacity with 26 foot canopy tops with a minimum of 90 inch canopy post
One (1) 5,000lb minimum load capacity with 24 foot canopy tops with standard canopy post

Hoist Common Requirements

Top and Bottom Brace Kits
No less than 200lbs of Bottom Weights
Aluminum Construction V-Frame and Cradle
Hydraulic Power System with a total Solar-Powered DC operating component
Stainless Steel Cables with a minimum 15 year warranty
Stainless/Brass Fasteners
Wireless Remote with a Dockside Up-Down Switch
2 Bunk Standard Boat Support
Leg Extensions for Deep Water
Load Guides - Glide-Rail with Step
Motor Stop
Solar Powered Battery Charger
Battery that meets the recommendation to operate the hoist

One (1) 7,000lb minimum load capacity with 26 foot canopy tops with a minimum of 124 inch canopy post

The DNR has four (4) used boat hoists for trade-in which are located at 15398 Crane Street, Clear Lake, Iowa 50428. Contractors are strongly encouraged to physically inspect them before providing a quote. The DNR will not renegotiate the value of the trade-in after the quotes deadline for submission has passed. The hoists have dead zebra mussels attached to them and the successful Contractor will be required to remove them prior to transporting the hoist from their current location. This will include cleaning and removing all plants, animals, and foreign objects, ensure all water from the equipment is drained, rinse entire hoist using high pressure hot water, dry, and dispose of all plants, animals, and foreign objects in the appropriate trash container. Contractors are not required to include the trade-ins on their quotes and have the discretion to include any combination of them if so desired. The DNR will award the contract to the Contractor providing the lowest overall cost including trade-in values.
