If multiple dental plan contractors are awarded, Iowa HHS intends to pay the same capitation rate for each dental plan; however, the final capitation rates may vary between dental plans for elements as described in the last section of the State Fiscal Year (SFY) 2027 Rate Estimate Narrative available to prospective bidders in the bidder's library or at the discretion of Iowa HHS. Iowa HHS's actuary will develop and certify the actuarially sound rates which may include capitation payment rate differentials, if necessary. This information will be communicated to the awarded dental plan contractors during the proposed timeline for capitation rate adjustments following the award of the RFP.
