### Amendment No. 1 to Agreement No. 2023-BUS-0201

This Amendment No. 1 (“**Amendment**”) to contract number 2023-BUS-0201 (“**Agreement**”) (leveraging NASPO ValuePoint Master Agreement 18091790030 (“**Master**”)), signed August 8, 2023, by and between the State of Iowa, acting by and through the Department of Management, and HHS Technology Group, LLC (“**Vendor**”), is made, entered into, and effective as of the date of last signature below. This Amendment will remain coterminous with the Agreement. The Amendment modifies, to the extent specified below, the terms and conditions of the Agreement:

**Section 1: Background.** Administration fee is removed. Language from the NASPO Master Agreement states: “A State cannot assess a procurement administrative fee if the State requests Enhanced Federal Funding Participation reimbursement from CMS for procurement expenditures”. The State of Iowa has requested CMS reimbursement. Additionally, the initial Date of Expiration in the Agreement reflects May 28, 2026, which is one year after the initial base term of the Master Agreement and, consequently, two (2) annual renewals. Finally, the Office of the Chief Information Officer (OCIO) ceased being an independent department of state government in 2023. OCIO is now known as the Division of Information Technology within the Department of Management (DOM DoIT). For contracting purposes, the Director of the Department of Management now has signatory authority for this contract as opposed to the Chief Information Officer. Iowa Code ch. 8 (2024).

### Section 2: Amendment to the Agreement.



**Revision 1:** Section 4.13 - Administration Fees is removed. The vendor is not obligated to pay administration fees for the entire term of the contract. The participating entity is using Enhanced Federal Funding Participation reimbursement from CMS.

**Revision 1:** On the CD&E page, the Date of Expiration shall reflect May 31, 2025. The Annual Extensions shall reflect: Up to three (3) annual renewals.

**Revision 2:** Throughout the Agreement, where the Office of the Chief Information Officer or OCIO is referenced, the Agreement shall read Department of Management or DOM.

**Section 3: Ratification and Authorization.** Except as expressly amended and supplemented herein, the Agreement shall remain in full force and effect, and the parties hereby ratify and confirm the terms and conditions thereof. Each party to this Amendment represents and warrants to the other that it has the right, power, and authority to enter into and perform its obligations under this Amendment, and it has taken all requisite actions (corporate, statutory, or otherwise) to approve execution, delivery and performance of this Amendment, and that this Amendment constitutes a legal, valid, and binding obligation.

**Section 4: Execution.** In consideration of the mutual covenants set forth above and for other good and valuable consideration, the receipt, adequacy and legal sufficiency of which are hereby acknowledged, the parties have entered into the above Amendment and have caused their duly authorized representatives to execute this Amendment.
