

COST PROPOSAL

National Car Charging has achieved its position as the nation's largest privately-held specialty EVSE distributor by providing a great value combined with a high level of service.

In order to keep costs to our customers low, we accept EFT/ACH and State Warrants as our preferred payment methods. We have the ability to accept State Pcards, however due to our aggressive pricing, such payments necessitate a 3.5% cost recovery fee.

However, it is our policy to offer early payment discounts. For this proposal NCC would offer state buyers a 2% discount if payment is made within 15 days and 1% if payment is made within 30 days.

Alternative Financing Mechanisms

In addition to purchasing, we can offer two other options, ChargePoint As A Service (CPAAS) or traditional leasing.

With CPAAS, the cost is \$2,400/year for a 5-year term for a dual-port unit and includes everything needed for total station management. While ChargePoint technically retains title to the unit, the site host maintains all control, including how it is programmed and receives the revenue it would receive had it been purchased outright. In addition to the networking plan, CPAAS includes Assure during the entire length of the term and CPAAS also guarantees that there will be no product obsolescence. Should a hardware upgrade be necessary to continue to function, ChargePoint would replace the hardware at no extra charge during the term. At the end of 5 years, a variety of options will be offered (to be determined).

Alternatively, we can offer a traditional leasing scenario. Under the leasing plan, the site host can pick a term from 2 to 5 years and can buy out the equipment for \$1 at the end of the term. Up to 40% of the total cost can represent installation (in other words, hardware/software must represent at least 60% of the cost). Since every package is different, the best way to represent leasing is as follows:

- 2-years: \$52 in monthly lease payment for every \$1,000 financed.
- 3-years: \$36 in monthly lease payment for every \$1,000 financed.
- 4-years: \$29 in monthly lease payment for every \$1,000 financed.
- 5-years: \$24 in monthly lease payment for every \$1,000 financed.
