This agreement DOES NOT auto-renew at the end of the term.

USING EXPORTS

After making payment, you will have the ability to utilize your limited exports of line item, bid, contract or contact search results (excludes attachments). All accounts have 5,000 result exports per month unless more were purchased or applied to your account. Each line item, bid, contract or contact in a search result uses a single export credit. Any unused credits will not carry over.
