THIS AMENDMENT is made by and between The University of Iowa, Iowa City, Iowa, Iowa State University, Ames, Iowa, and The University of Northern Iowa, Cedar Falls, Iowa (hereinafter "Universities") and Wynn O Jones and Associates Incorporated, PO Box 318, Schofield, WI, 54476-0318 (hereinafter "Supplier").

WHEREAS, it is the desire of the Universities to continue to work with the Supplier to provide Lab Furniture and Casework (hereinafter "Services") for The University of Iowa, Iowa State University, and the University of Northern Iowa, per the originally signed Memorandum of Agreement, and

WHEREAS, the Universities have deemed that the Services are to be continued, as described in the University of Iowa Request for Proposal number (RFP) 18030 and all addenda related thereto, which was expressly incorporated by reference within the originally signed Agreement, will still be served through the continued use of the Supplier, and

WHEREAS, the Universities have determined that the continued Services of the Supplier best serves the interest of the Universities,

THEREFORE, in consideration of the promises and the mutual covenants contained therein, the Universities and Supplier agree as follows:

TERM

This Amendment #1 to the originally signed Agreement shall extend the Agreement for an additional one (1) year, through and including May 31, 2027 unless earlier terminated in accordance with the originally signed Agreement.

Thereafter, the Agreement may be extended for an additional one (1) year based upon written mutual consent of the University and Supplier.

All terms, conditions and related fees as agreed to in the originally signed Agreement shall remain in effect for the duration of this Amendment #1.
